Rule-Based Classifier

- Classify records by using a collection of “if... then...” rules
- Rule: $(Condition) \rightarrow y$
 - where
 - ◆ *Condition* is a conjunctions of attributes
 - ◆ y is the class label
 - *LHS*: rule antecedent or condition
 - *RHS*: rule consequent
 - Examples of classification rules:
 - ◆ $(\text{Blood Type}=\text{Warm}) \wedge (\text{Lay Eggs}=\text{Yes}) \rightarrow \text{Birds}$
 - ◆ $(\text{Taxable Income} < 50\text{K}) \wedge (\text{Refund}=\text{Yes}) \rightarrow \text{Evade}=\text{No}$

R1: (Give Birth = no) \wedge (Can Fly = yes) \rightarrow Birds

R2: (Give Birth = no) \wedge (Live in Water = yes) \rightarrow Fishes

R3: (Give Birth = yes) \wedge (Blood Type = warm) \rightarrow Mammals

R4: (Give Birth = no) \wedge (Can Fly = no) \rightarrow Reptiles

R5: (Live in Water = sometimes) \rightarrow Amphibians

Application of Rule-Based Classifier

- A rule r covers an instance x if the attributes of the instance satisfy the condition of the rule

R1: (Give Birth = no) \wedge (Can Fly = yes) \rightarrow Birds

R2: (Give Birth = no) \wedge (Live in Water = yes) \rightarrow Fishes

R3: (Give Birth = yes) \wedge (Blood Type = warm) \rightarrow Mammals

R4: (Give Birth = no) \wedge (Can Fly = no) \rightarrow Reptiles

R5: (Live in Water = sometimes) \rightarrow Amphibians

Name	Blood Type	Give Birth	Can Fly	Live in Water	Class
hawk	warm	no	yes	no	?
grizzly bear	warm	yes	no	no	?

The rule R1 covers a hawk \Rightarrow Bird

The rule R3 covers the grizzly bear \Rightarrow Mammal

Rule Coverage and Accuracy

- Coverage of a rule:
 - Fraction of records that satisfy the antecedent of a rule
- Accuracy of a rule:
 - Fraction of records that satisfy both the antecedent and consequent of a rule

(Status=Single) → No

Coverage = 40%, Accuracy = 50%

How does Rule-based Classifier Work?

R1: (Give Birth = no) \wedge (Can Fly = yes) \rightarrow Birds

R2: (Give Birth = no) \wedge (Live in Water = yes) \rightarrow Fishes

R3: (Give Birth = yes) \wedge (Blood Type = warm) \rightarrow Mammals

R4: (Give Birth = no) \wedge (Can Fly = no) \rightarrow Reptiles

R5: (Live in Water = sometimes) \rightarrow Amphibians

Name	Blood Type	Give Birth	Can Fly	Live in Water	Class
lemur	warm	yes	no	no	?
turtle	cold	no	no	sometimes	?
dogfish shark	cold	yes	no	yes	?

A lemur triggers rule R3, so it is classified as a mammal

A turtle triggers both R4 and R5

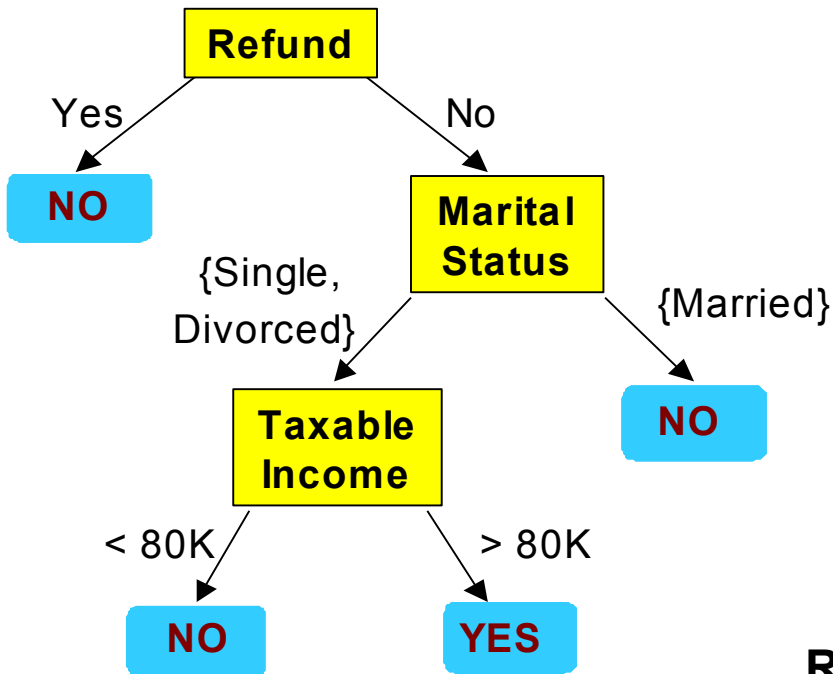
A dogfish shark triggers none of the rules

Characteristics of Rule-Based Classifier

- Mutually exclusive rules
 - Classifier contains mutually exclusive rules if the rules are independent of each other
 - Every record is covered by **at most** one rule

- Exhaustive rules
 - Classifier has exhaustive coverage if it accounts for every possible combination of attribute values
 - Each record is covered by **at least** one rule

From Decision Trees To Rules



Classification Rules

(Refund=Yes) ==> No

(Refund=No, Marital Status={Single,Divorced}, Taxable Income<80K) ==> No

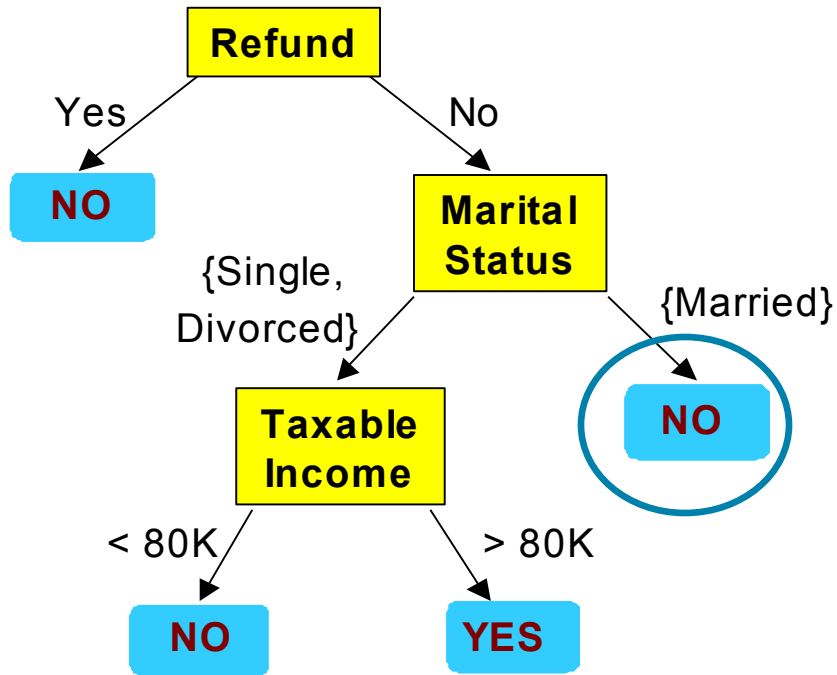
(Refund=No, Marital Status={Single,Divorced}, Taxable Income>80K) ==> Yes

(Refund=No, Marital Status={Married}) ==> No

Rules are mutually exclusive and exhaustive

Rule set contains as much information as the tree

Rules Can Be Simplified

Initial Rule: $(\text{Refund}=\text{No}) \wedge (\text{Status}=\text{Married}) \rightarrow \text{No}$

Simplified Rule: $(\text{Status}=\text{Married}) \rightarrow \text{No}$

Effect of Rule Simplification

- Rules are no longer mutually exclusive
 - A record may trigger more than one rule
 - Solution?
 - ◆ Ordered rule set
 - ◆ Unordered rule set – use voting schemes

- Rules are no longer exhaustive
 - A record may not trigger any rules
 - Solution?
 - ◆ Use a default class

Ordered Rule Set

- Rules are rank ordered according to their priority
 - An ordered rule set is known as a decision list
- When a test record is presented to the classifier
 - It is assigned to the class label of the highest ranked rule it has triggered
 - If none of the rules fired, it is assigned to the default class


R1: (Give Birth = no) \wedge (Can Fly = yes) \rightarrow Birds

R2: (Give Birth = no) \wedge (Live in Water = yes) \rightarrow Fishes

R3: (Give Birth = yes) \wedge (Blood Type = warm) \rightarrow Mammals

Rule Ordering Schemes

- Rule-based ordering
 - Individual rules are ranked based on their quality
- Class-based ordering
 - Rules that belong to the same class appear together

Rule-based Ordering

(Refund=Yes) ==> No

(Refund=No, Marital Status={Single,Divorced},
Taxable Income<80K) ==> No

(Refund=No, Marital Status={Single,Divorced},
Taxable Income>80K) ==> Yes

(Refund=No, Marital Status={Married}) ==> No

Class-based Ordering

(Refund=Yes) ==> No

(Refund=No, Marital Status={Single,Divorced},
Taxable Income<80K) ==> No

(Refund=No, Marital Status={Married}) ==> No

(Refund=No, Marital Status={Single,Divorced},
Taxable Income>80K) ==> Yes

Building Classification Rules

- Direct Method:

- ◆ Extract rules directly from data
- ◆ e.g.: RIPPER, CN2, Holte's 1R

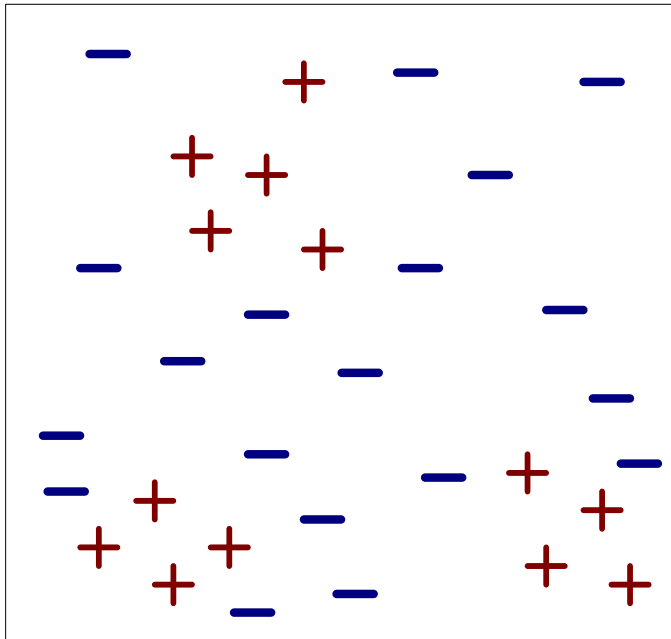
- Indirect Method:

- ◆ Extract rules from other classification models (e.g. decision trees, neural networks, etc).
- ◆ e.g: C4.5rules

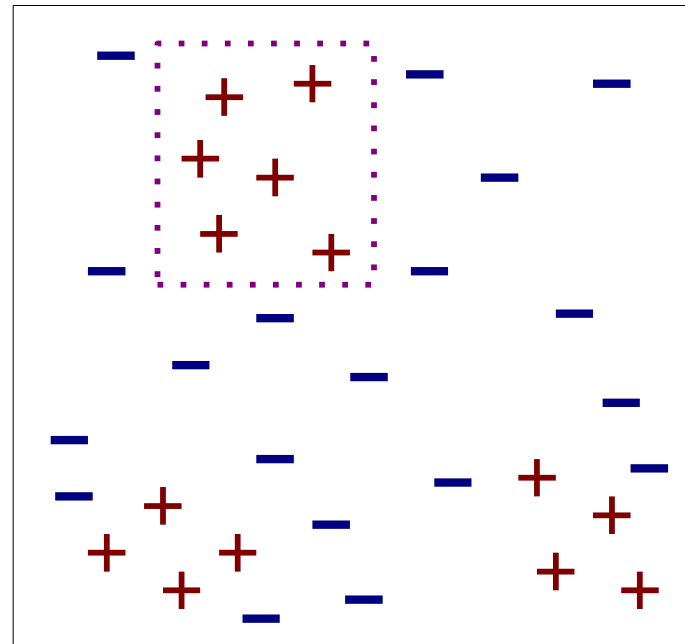
Direct Method: Sequential Covering

1. Start from an empty rule
2. Grow a rule using the Learn-One-Rule function
3. Remove training records covered by the rule
4. Repeat Step (2) and (3) until stopping criterion is met

Example of Sequential Covering

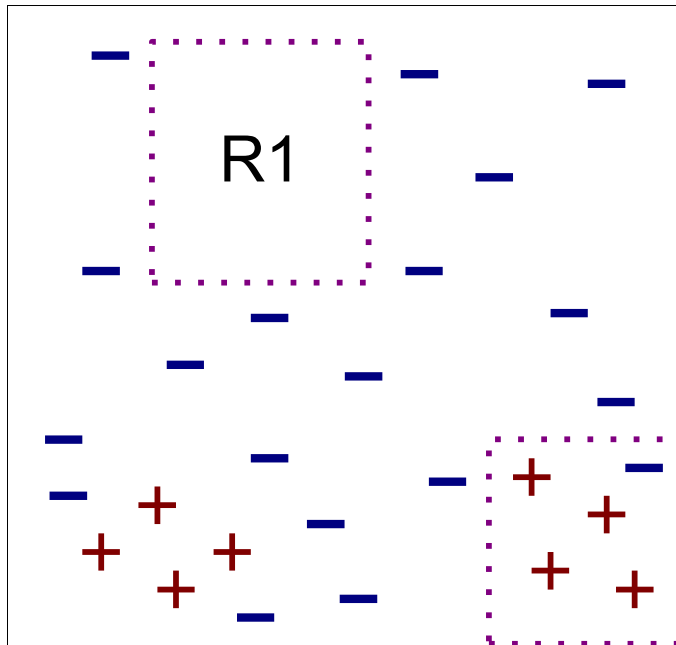


(i) Original Data

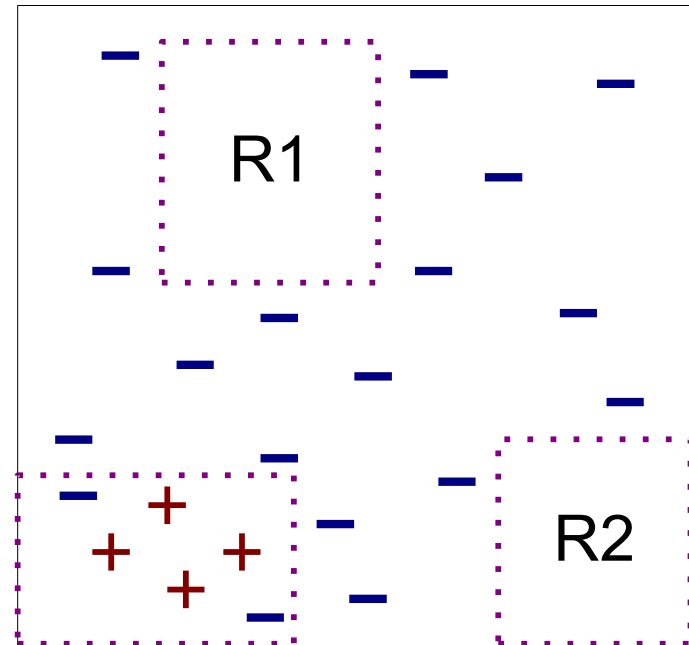


(ii) Step 1

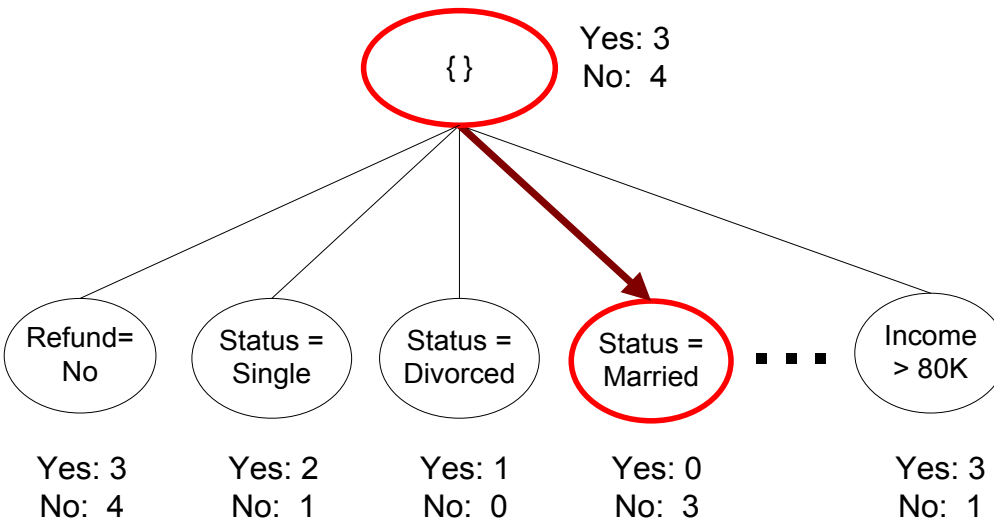

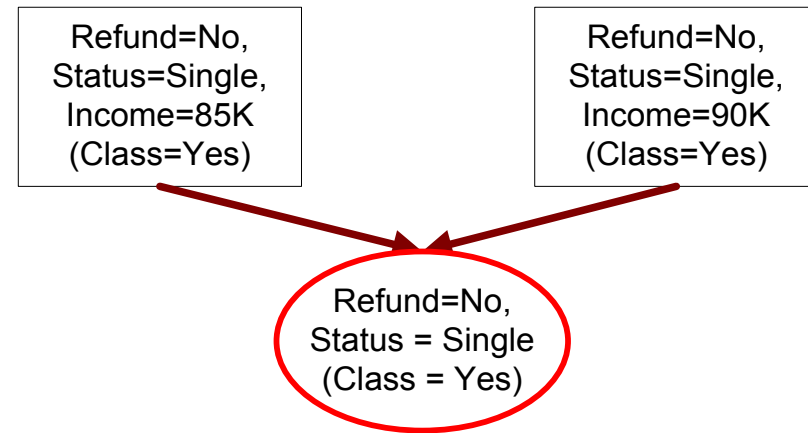
- Rule Growing

- Stopping Criterion

Rule Growing

- Two common strategies



(a) General-to-specific



(b) Specific-to-general

Rule Growing (Examples)

- CN2 Algorithm:

- Start from an empty conjunct: $\{\}$
- Add conjuncts that minimizes the entropy measure: $\{A\}, \{A,B\}, \dots$
- Determine the rule consequent by taking majority class of instances covered by the rule

- RIPPER Algorithm:

- Start from an empty rule: $\{\} \Rightarrow \text{class}$
- Add conjuncts that maximizes FOIL's information gain measure:
 - ◆ $R_0: \{\} \Rightarrow \text{class}$ (initial rule)
 - ◆ $R_1: \{A\} \Rightarrow \text{class}$ (rule after adding conjunct)
 - ◆ $\text{Gain}(R_0, R_1) = t [\log(p_1/(p_1+n_1)) - \log(p_0/(p_0 + n_0))]$
 - ◆ where t : number of positive instances covered by both R_0 and R_1
 - p_0 : number of positive instances covered by R_0
 - n_0 : number of negative instances covered by R_0
 - p_1 : number of positive instances covered by R_1
 - n_1 : number of negative instances covered by R_1

Instance Elimination

- **Why do we need to eliminate instances?**

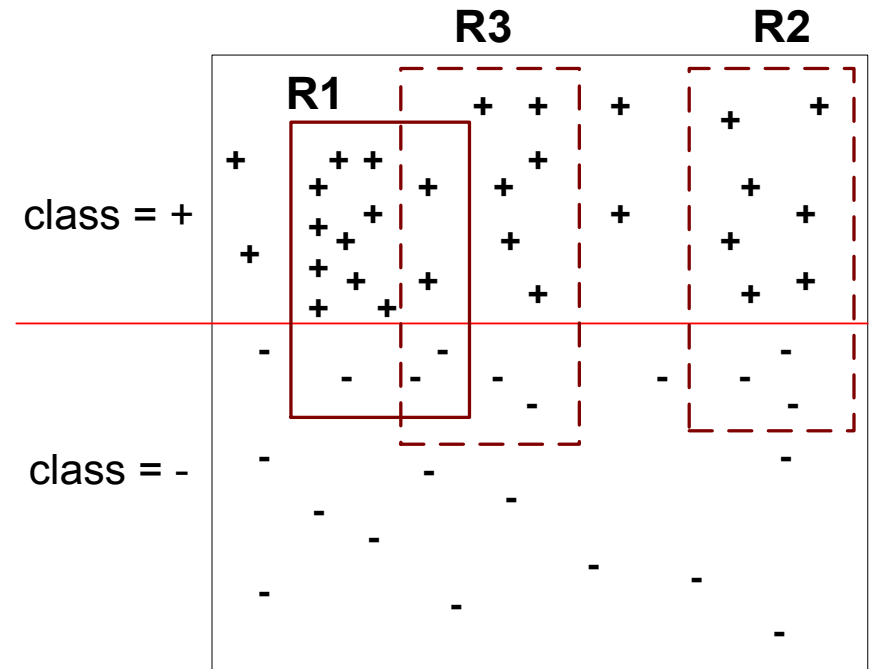
- Otherwise, the next rule is identical to previous rule

- **Why do we remove positive instances?**

- Ensure that the next rule is different
- Avoid the overestimation of rule accuracy (R3)

- **Why do we remove negative instances?**

- Prevent underestimating accuracy of rule (of R3)
- Compare rules R2 and R3 in the diagram



Rule Evaluation

- Metrics:

- Accuracy = $\frac{n_c}{n}$

- Laplace = $\frac{n_c + 1}{n + k}$

- M-estimate = $\frac{n_c + kp}{n + k}$

n : Number of instances covered by rule

n_c : Number of positive instances covered by rule

k : Number of classes

p : Prior probability

Stopping Criterion and Rule Pruning

- Stopping criterion
 - Compute the gain
 - If gain is not significant, discard the new rule

- Rule Pruning
 - Similar to post-pruning of decision trees
 - Reduced Error Pruning:
 - ◆ Remove one of the conjuncts in the rule
 - ◆ Compare error rate on validation set before and after pruning
 - ◆ If error improves, prune the conjunct

Summary of Direct Method

- Grow a single rule
- Remove Instances from rule
- Prune the rule (if necessary)
- Add rule to Current Rule Set
- Repeat

Direct Method: RIPPER

- **For 2-class problem, choose one of the classes as positive class, and the other as negative class**
 - Learn rules for positive class
 - Negative class will be default class
- **For multi-class problem**
 - Order the classes according to increasing class prevalence (fraction of instances that belong to a particular class)
 - Learn the rule set for smallest class first, treat the rest as negative class
 - Repeat with next smallest class as positive class

Direct Method: RIPPER

- Growing a rule:
 - Start from empty rule
 - Add conjuncts as long as they improve FOIL's information gain
 - Stop when rule no longer covers negative examples
 - Prune the rule immediately using incremental reduced error pruning
 - **Measure for pruning: $v = (p-n)/(p+n)$**
 - ◆ p: number of positive examples covered by the rule in the validation set
 - ◆ n: number of negative examples covered by the rule in the validation set
 - Pruning method: delete any final sequence of conditions that maximizes v

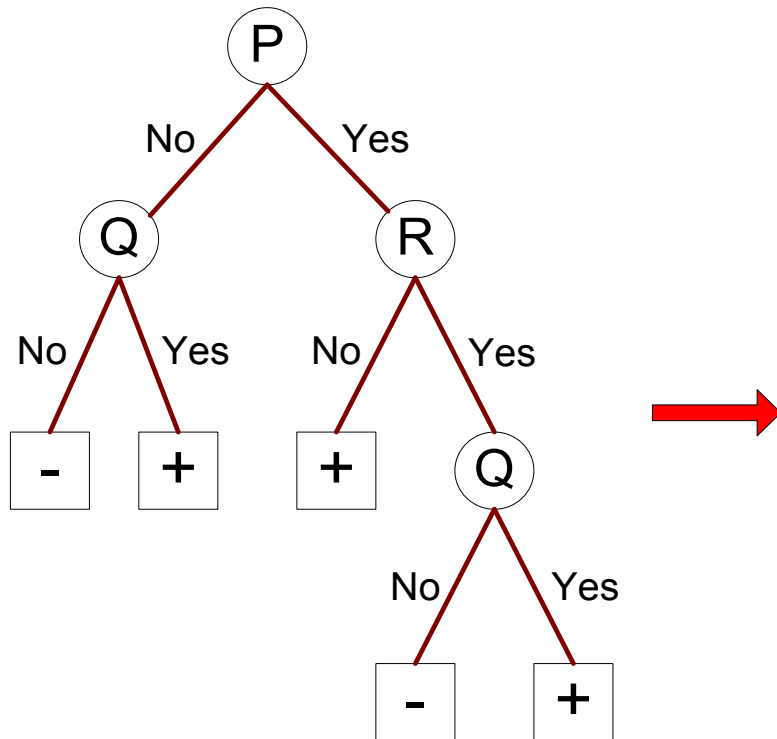
Direct Method: RIPPER

- Building a Rule Set:
 - Use sequential covering algorithm
 - ◆ Finds the best rule that covers the current set of positive examples
 - ◆ Eliminate both positive and negative examples covered by the rule
 - Each time a rule is added to the rule set, compute the new description length
 - ◆ stop adding new rules when the new description length is d bits longer than the smallest description length obtained so far

Direct Method: RIPPER

- Optimize the rule set:
 - For each rule r in the rule set R
 - ◆ Consider 2 alternative rules:
 - Replacement rule (r^*): grow new rule from scratch
 - Revised rule (r'): add conjuncts to extend the rule r
 - ◆ Compare the rule set for r against the rule set for r^* and r'
 - ◆ Choose rule set that minimizes MDL principle
 - Repeat rule generation and rule optimization for the remaining positive examples

Indirect Methods



Rule Set

- r1: (P=No, Q=No) ==> -
- r2: (P=No, Q=Yes) ==> +
- r3: (P=Yes, R=No) ==> +
- r4: (P=Yes, R=Yes, Q=No) ==> -
- r5: (P=Yes, R=Yes, Q=Yes) ==> +

Indirect Method: C4.5rules

- Extract rules from an unpruned decision tree
- For each rule, $r: A \rightarrow y$,
 - consider an alternative rule $r' : A' \rightarrow y$ where A' is obtained by removing one of the conjuncts in A
 - Compare the pessimistic error rate for r against all r' s
 - Prune if one of the r' s has lower pessimistic error rate
 - Repeat until we can no longer improve generalization error

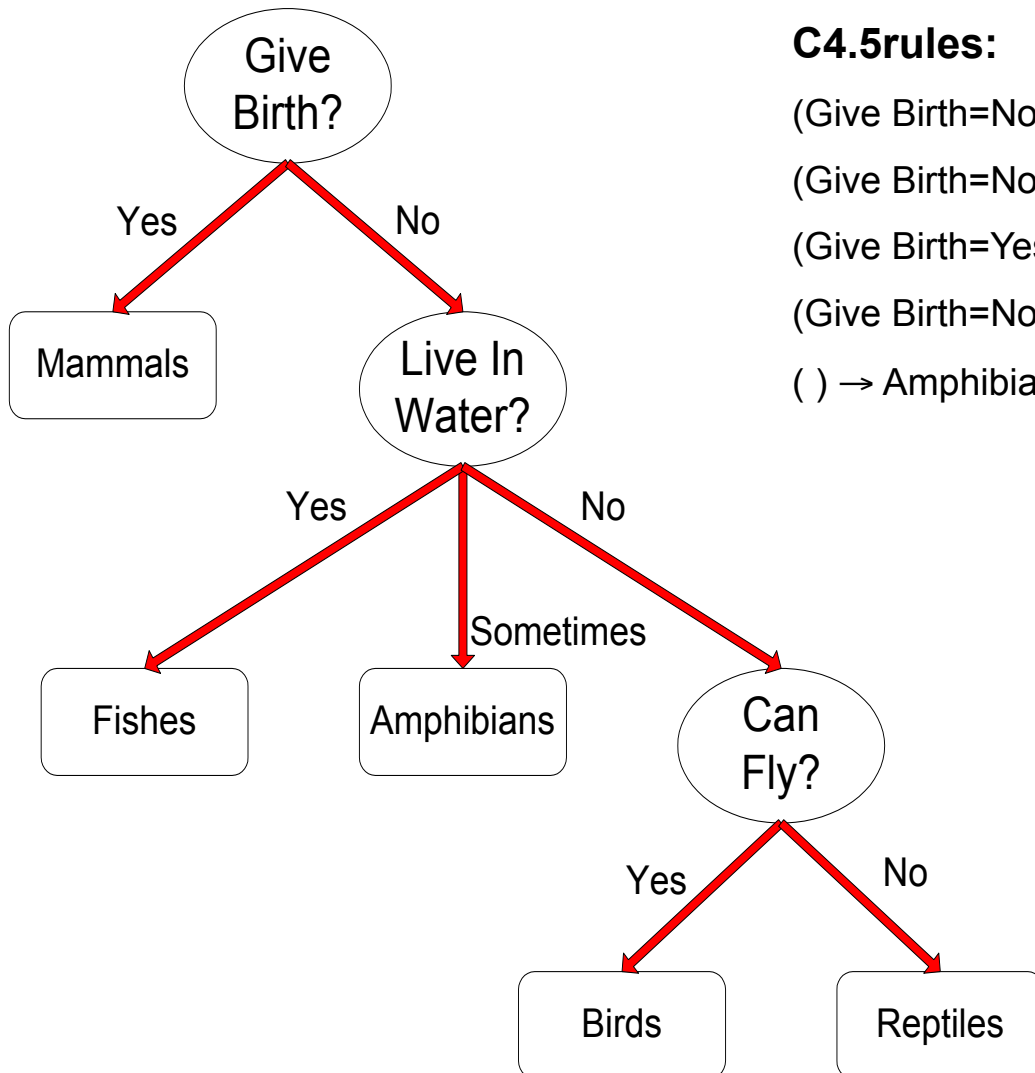
Indirect Method: C4.5rules

- Instead of ordering the rules, order subsets of rules (**class ordering**)
 - Each subset is a collection of rules with the same rule consequent (class)
 - Compute description length of each subset
 - ◆ Description length = $L(\text{error}) + g L(\text{model})$
 - ◆ g is a parameter that takes into account the presence of redundant attributes in a rule set (default value = 0.5)

() → Mammals

Advantages of Rule-Based Classifiers

- As highly expressive as decision trees
- Easy to interpret
- Easy to generate
- Can classify new instances rapidly
- Performance comparable to decision trees

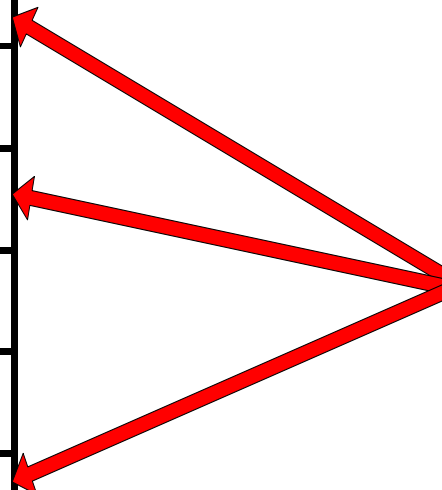

- Store the training records
- Use training records to predict the class label of unseen cases

Instance Based Classifiers

- Examples:
 - Rote-learner
 - ◆ Memorizes entire training data and performs classification only if attributes of record match one of the training examples exactly
 - Nearest neighbor
 - ◆ Uses k “closest” points (nearest neighbors) for performing classification

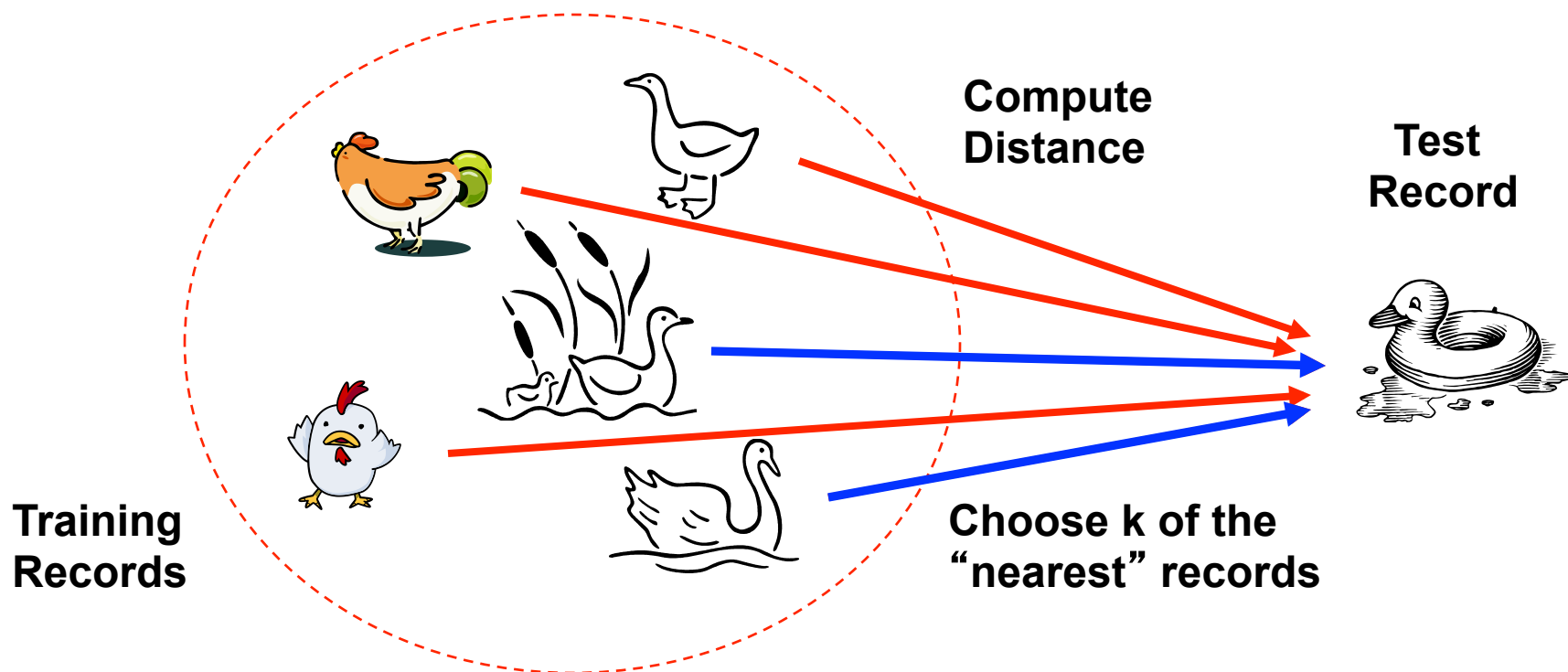

- Basic idea:

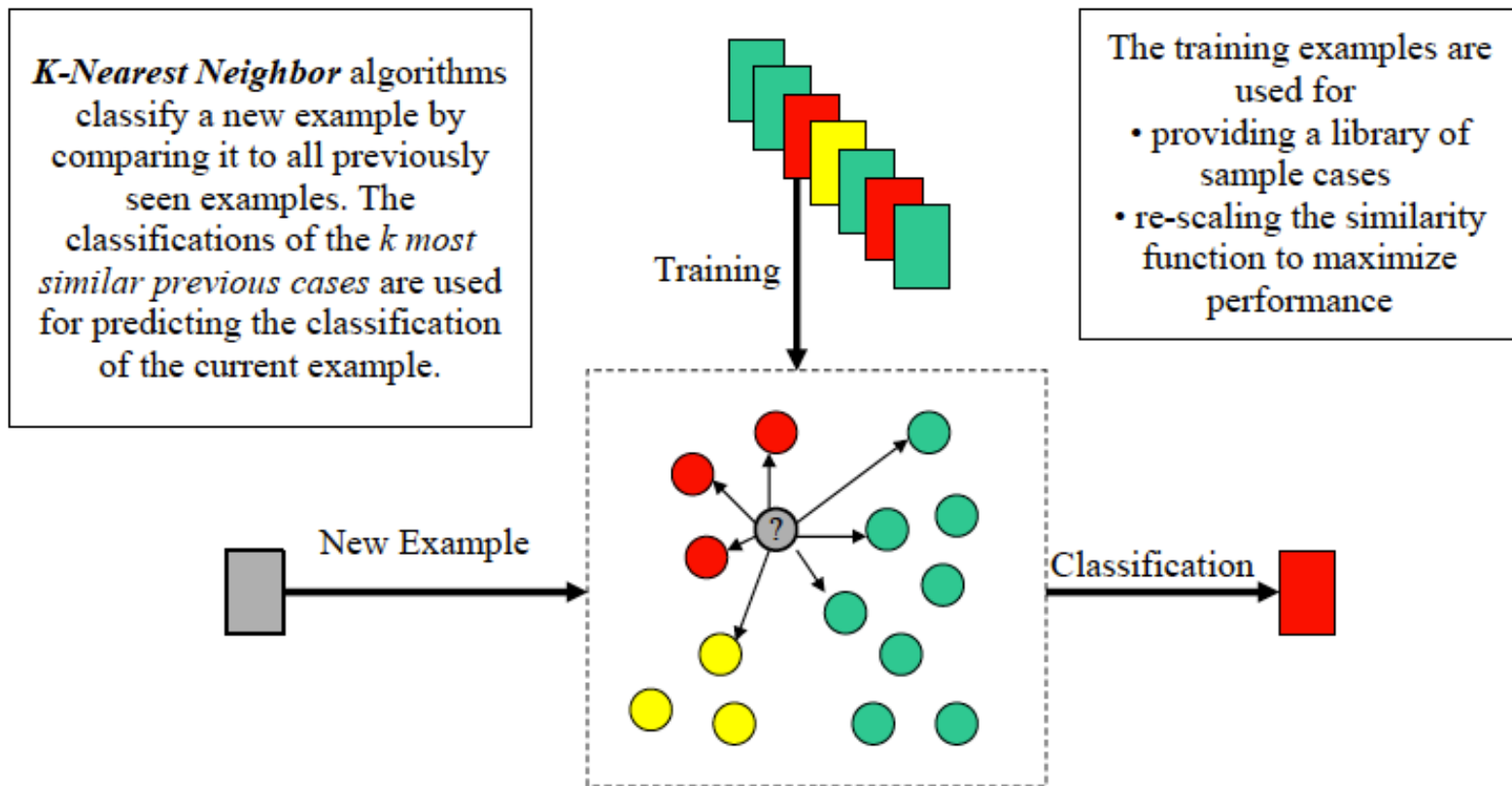
- If it walks like a duck, quacks like a duck, then it's probably a duck



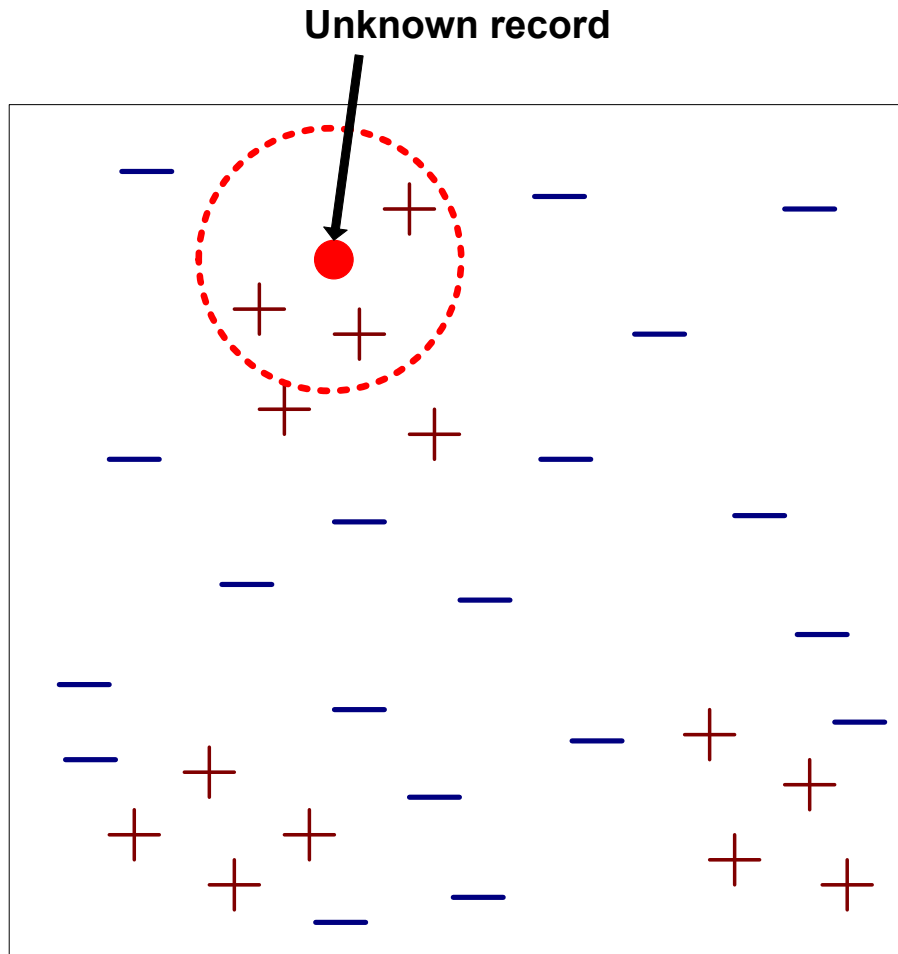

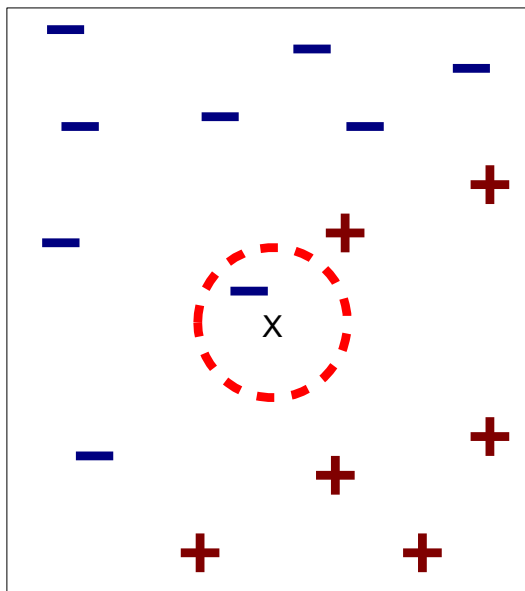


Nearest-Neighbor Classifiers

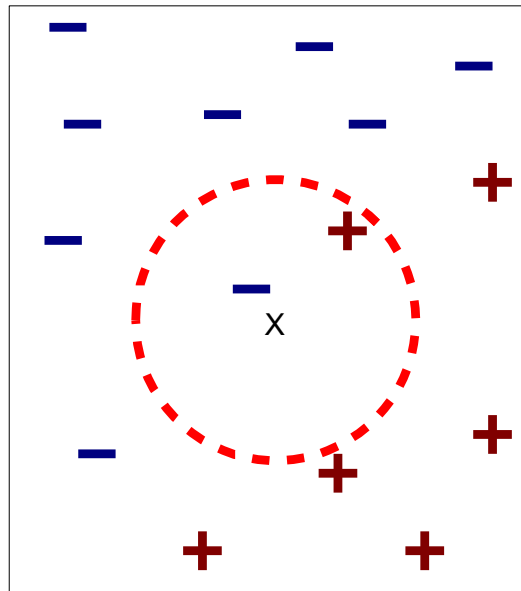


- Requires three things
 - The set of stored records
 - Distance Metric to compute distance between records
 - The value of k , the number of nearest neighbors to retrieve
- To classify an unknown record:
 - Compute distance to other training records
 - Identify k nearest neighbors
 - Use class labels of nearest neighbors to determine the class label of unknown record (e.g., by taking majority vote)

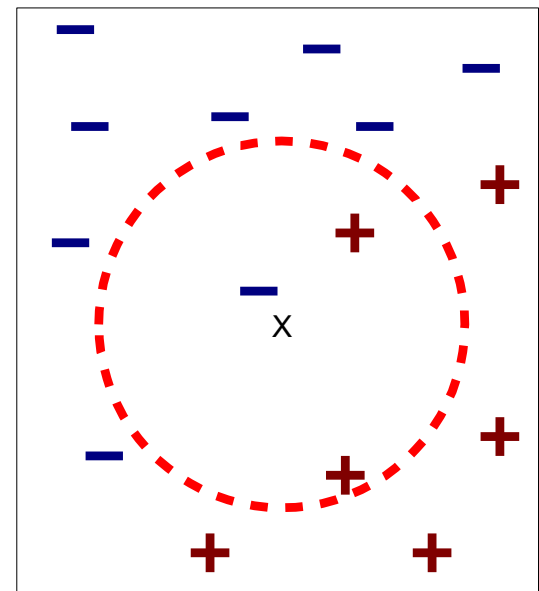
Definition of Nearest Neighbor



(a) 1-nearest neighbor



(b) 2-nearest neighbor

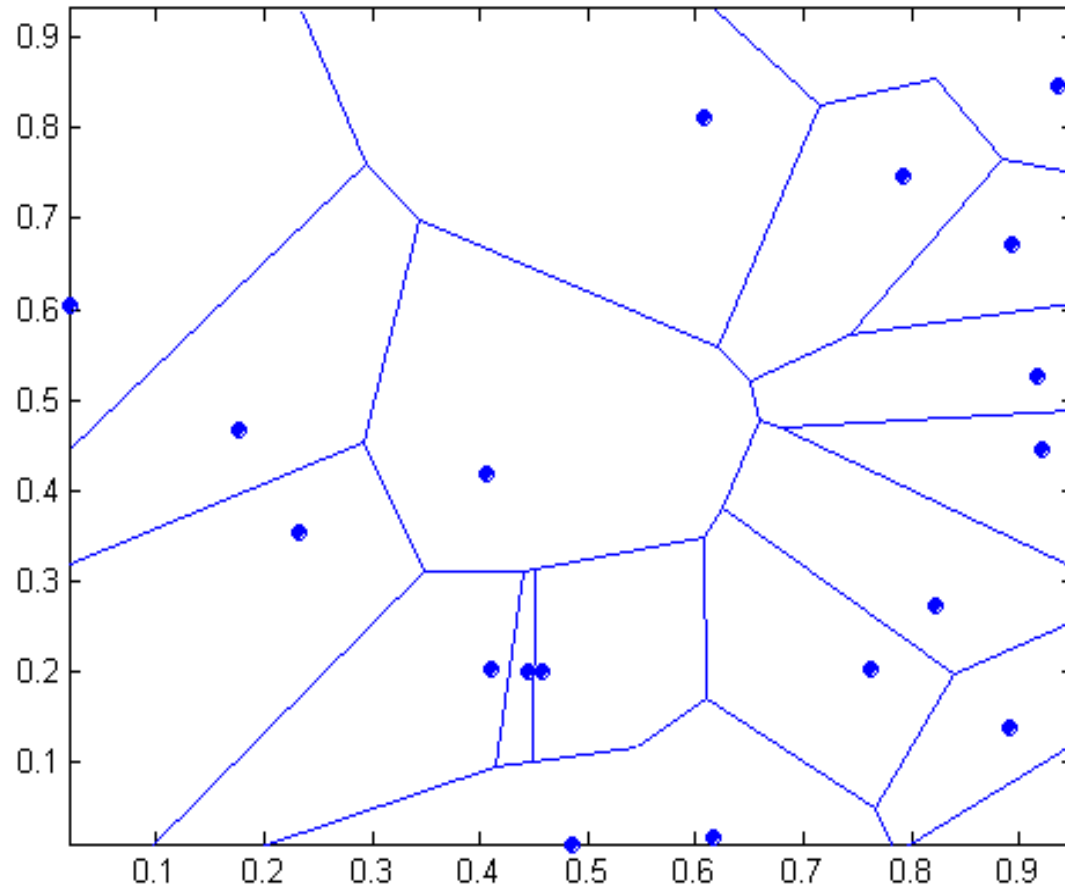


(c) 3-nearest neighbor

K-nearest neighbors of a record x are data points that have the k smallest distance to x

1 nearest-neighbor

Voronoi Diagram



Nearest Neighbor Classification

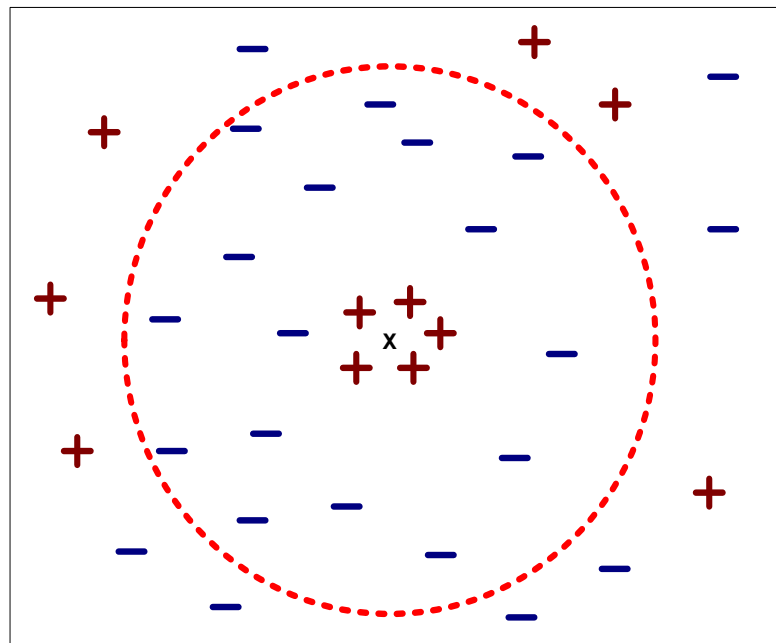
- Compute distance between two points:
 - Euclidean distance

$$d(p, q) = \sqrt{\sum_i (p_i - q_i)^2}$$

- Determine the class from nearest neighbor list
 - take the majority vote of class labels among the k-nearest neighbors
 - Weigh the vote according to distance
 - ◆ weight factor, $w = 1/d^2$

Nearest Neighbor Classification...

- Choosing the value of k:
 - If k is too small, sensitive to noise points
 - If k is too large, neighborhood may include points from other classes



Nearest Neighbor Classification...

- Scaling issues

- Attributes may have to be scaled to prevent distance measures from being dominated by one of the attributes
- Example:
 - ◆ height of a person may vary from 1.5m to 1.8m
 - ◆ weight of a person may vary from 90lb to 300lb
 - ◆ income of a person may vary from \$10K to \$1M

Nearest Neighbor Classification...

- Problem with Euclidean measure:
 - High dimensional data
 - ◆ **curse of dimensionality**
 - Can produce counter-intuitive results

1 1 1 1 1 1 1 1 1 1 0

$d = 1.4142$

VS

1 0 0 0 0 0 0 0 0 0 0

$d = 1.4142$

- ◆ Solution: Normalize the vectors to unit length

Nearest neighbor Classification...

- k-NN classifiers are lazy learners
 - It does not build models explicitly
 - Unlike eager learners such as decision tree induction and rule-based systems
 - Classifying unknown records are relatively expensive

Example: PEBLS

- PEBLS: Parallel Exemplar-Based Learning System (Cost & Salzberg)
 - Works with both continuous and nominal features
 - ◆ For nominal features, distance between two nominal values is computed using modified value difference metric (MVDM)
 - Each record is assigned a weight factor
 - Number of nearest neighbor, $k = 1$

Example: PEBLS

- Modified value difference metric for nominal attributes:

$$d(v_1, v_2) = \sum_i | P(c_i|v_1) - P(c_i|v_2) |$$

- The distance between two attribute values is determined by the difference between their conditional class distributions

Distance between nominal attribute values:

$d(\text{Single}, \text{Married})$

$$= |2/4 - 0/4| + |2/4 - 4/4| = 1$$

$d(\text{Single}, \text{Divorced})$

$$= |2/4 - 1/2| + |2/4 - 1/2| = 0$$

$d(\text{Married}, \text{Divorced})$

$$= |0/4 - 1/2| + |4/4 - 1/2| = 1$$

$d(\text{Refund}=\text{Yes}, \text{Refund}=\text{No})$

$$= |0/3 - 3/7| + |3/3 - 4/7| = 6/7$$

$$d(V_1, V_2) = \sum_i \left| \frac{n_{1i}}{n_1} - \frac{n_{2i}}{n_2} \right|$$

Distance between record X and record Y:

$$\Delta(X, Y) = w_X w_Y \sum_{i=1}^d d(X_i, Y_i)^2$$

where: $w_X = \frac{\text{Number of times X is used for prediction}}{\text{Number of times X predicts correctly}}$

$w_X \cong 1$ if X makes accurate prediction most of the time

$w_X > 1$ if X is not reliable for making predictions

$x = (\text{yes}, \text{single}, 125\text{K})$

$y = (\text{no}, \text{married}, 100\text{K})$

$$d(x_1, y_1)^2 = d(\text{yes}, \text{no})^2 = (6/7)^2 = 36/49$$

$$d(x_2, y_2)^2 = d(\text{single}, \text{married})^2 = 1^2 = 1$$

$$d(x_3, y_3)^2 = d(125, 100)^2 = 252 = 625$$

P: Income dominates distance between objects.

S: Divide income by its standard deviation 45.63

$$d(x_3, y_3)^2 = d(2.74, 2.19)^2 = 0.552 = 0.3025$$

So the total distance is (assuming weights are 1):

$$\Delta(\mathbf{x}, \mathbf{y}) = \frac{36}{49} + 1 + 0.3025 = 2.04$$

Bayes Classifier

- A probabilistic framework for solving classification problems

- Conditional Probability:

$$P(C | A) = \frac{P(A, C)}{P(A)}$$

$$P(A | C) = \frac{P(A, C)}{P(C)}$$

- Bayes theorem:

$$P(C | A) = \frac{P(A | C)P(C)}{P(A)}$$

Example of Bayes Theorem

- Given:

- A doctor knows that meningitis causes stiff neck 50% of the time
- Prior probability of any patient having meningitis is 1/50,000
- Prior probability of any patient having stiff neck is 1/20

- If a patient has stiff neck, what's the probability he/she has meningitis?

$$P(M | S) = \frac{P(S | M)P(M)}{P(S)} = \frac{0.5 \times 1/50000}{1/20} = 0.0002$$

Bayesian Classifiers

- Consider each attribute and class label as random variables
- Given a record with attributes (A_1, A_2, \dots, A_n)
 - Goal is to predict class C
 - Specifically, we want to find the value of C that maximizes $P(C | A_1, A_2, \dots, A_n)$
- Can we estimate $P(C | A_1, A_2, \dots, A_n)$ directly from data?

Bayesian Classifiers

- Approach:

- compute the posterior probability $P(C | A_1, A_2, \dots, A_n)$ for all values of C using the Bayes theorem

$$P(C | A_1 A_2 \dots A_n) = \frac{P(A_1 A_2 \dots A_n | C) P(C)}{P(A_1 A_2 \dots A_n)}$$

- Choose value of C that maximizes $P(C | A_1, A_2, \dots, A_n)$
- Equivalent to choosing value of C that maximizes $P(A_1, A_2, \dots, A_n | C) P(C)$

- How to estimate $P(A_1, A_2, \dots, A_n | C)$?

Naïve Bayes Classifier

- Assume independence among attributes A_i when class is given:
 - $P(A_1, A_2, \dots, A_n | C) = P(A_1 | C) P(A_2 | C) \dots P(A_n | C)$
 - Can estimate $P(A_i | C)$ for all A_i and C .
 - New point is classified to C_j if $P(C_j) \prod P(A_i | C_j)$ is maximal.

- Class: $P(C) = N_c/N$

- e.g., $P(\text{No}) = 7/10$,
 $P(\text{Yes}) = 3/10$

- For discrete attributes:

$$P(A_i | C_k) = |A_{ik}| / N_{C_k}$$

- where $|A_{ik}|$ is number of instances having attribute A_i and belongs to class C_k

- Examples:

$$P(\text{Status}=\text{Married}|\text{No}) = 4/7$$

$$P(\text{Refund}=\text{Yes}|\text{Yes})=0$$

How to Estimate Probabilities from Data?

- For continuous attributes:
 - **Discretize** the range into bins
 - ◆ one ordinal attribute per bin
 - ◆ violates independence assumption ^k
 - **Two-way split:** $(A < v)$ or $(A > v)$
 - ◆ choose only one of the two splits as new attribute
 - **Probability density estimation:**
 - ◆ Assume attribute follows a normal distribution
 - ◆ Use data to estimate parameters of distribution (e.g., mean and standard deviation)
 - ◆ Once probability distribution is known, can use it to estimate the conditional probability $P(A_i|c)$

- Normal distribution:

$$P(A_i | c_j) = \frac{1}{\sqrt{2\pi\sigma_{ij}^2}} e^{-\frac{(A_i - \mu_{ij})^2}{2\sigma_{ij}^2}}$$

- One for each (A_i, c_i) pair
- For (Income, Class=No):
 - If Class=No
 - ◆ sample mean = 110
 - ◆ sample variance = 2975

$$P(\text{Income} = 120 | \text{No}) = \frac{1}{\sqrt{2\pi(54.54)}} e^{-\frac{(120-110)^2}{2(2975)}} = 0.0072$$

Example of Naïve Bayes Classifier

Given a Test Record:

$$X = (\text{Refund} = \text{No}, \text{Married}, \text{Income} = 120\text{K})$$

naive Bayes Classifier:

$$P(\text{Refund}=\text{Yes}|\text{No}) = 3/7$$

$$P(\text{Refund}=\text{No}|\text{No}) = 4/7$$

$$P(\text{Refund}=\text{Yes}|\text{Yes}) = 0$$

$$P(\text{Refund}=\text{No}|\text{Yes}) = 1$$

$$P(\text{Marital Status}=\text{Single}|\text{No}) = 2/7$$

$$P(\text{Marital Status}=\text{Divorced}|\text{No})=1/7$$

$$P(\text{Marital Status}=\text{Married}|\text{No}) = 4/7$$

$$P(\text{Marital Status}=\text{Single}|\text{Yes}) = 2/7$$

$$P(\text{Marital Status}=\text{Divorced}|\text{Yes})=1/7$$

$$P(\text{Marital Status}=\text{Married}|\text{Yes}) = 0$$

For taxable income:

If class=No: sample mean=110

sample variance=2975

If class=Yes: sample mean=90

sample variance=25

- $P(X|\text{Class}=\text{No}) = P(\text{Refund}=\text{No}|\text{Class}=\text{No})$
 $\times P(\text{Married}|\text{Class}=\text{No})$
 $\times P(\text{Income}=120\text{K}|\text{Class}=\text{No})$
 $= 4/7 \times 4/7 \times 0.0072 = 0.0024$
- $P(X|\text{Class}=\text{Yes}) = P(\text{Refund}=\text{No}|\text{Class}=\text{Yes})$
 $\times P(\text{Married}|\text{Class}=\text{Yes})$
 $\times P(\text{Income}=120\text{K}|\text{Class}=\text{Yes})$
 $= 1 \times 0 \times 1.2 \times 10^{-9} = 0$

Since $P(X|\text{No})P(\text{No}) > P(X|\text{Yes})P(\text{Yes})$

Therefore $P(\text{No}|X) > P(\text{Yes}|X)$

$\Rightarrow \text{Class} = \text{No}$

Naïve Bayes Classifier

- If one of the conditional probability is zero, then the entire expression becomes zero
 - Problems when the training set is small

- Probability estimation:

$$\text{Original : } P(A_i | C) = \frac{N_{ic}}{N_c}$$

$$\text{Laplace : } P(A_i | C) = \frac{N_{ic} + 1}{N_c + c}$$

$$\text{m - estimate : } P(A_i | C) = \frac{N_{ic} + mp}{N_c + m}$$

c: number of classes

p: prior probability

m: equivalent sample size (parameter)

m: trade-off between p and the observed prob.
 N_{ic} / N_c

$$P(A | M)P(M) = 0.06 \times \frac{7}{20} = 0.021$$

$$P(A | N)P(N) = 0.004 \times \frac{13}{20} = 0.0027$$

$P(A|M)P(M) > P(A|N)P(N)$

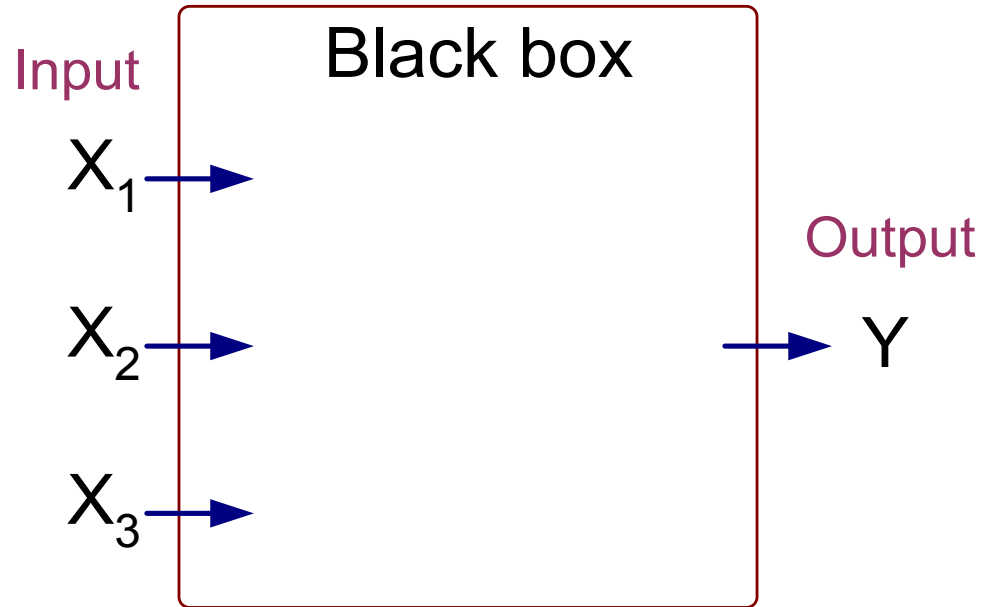

Naïve Bayes (Summary)

- Robust to isolated noise points
- Handle missing values by ignoring the instance during probability estimate calculations
- Robust to irrelevant attributes
- Independence assumption may not hold for some attributes
 - Use other techniques such as Bayesian Belief Networks (BBN)

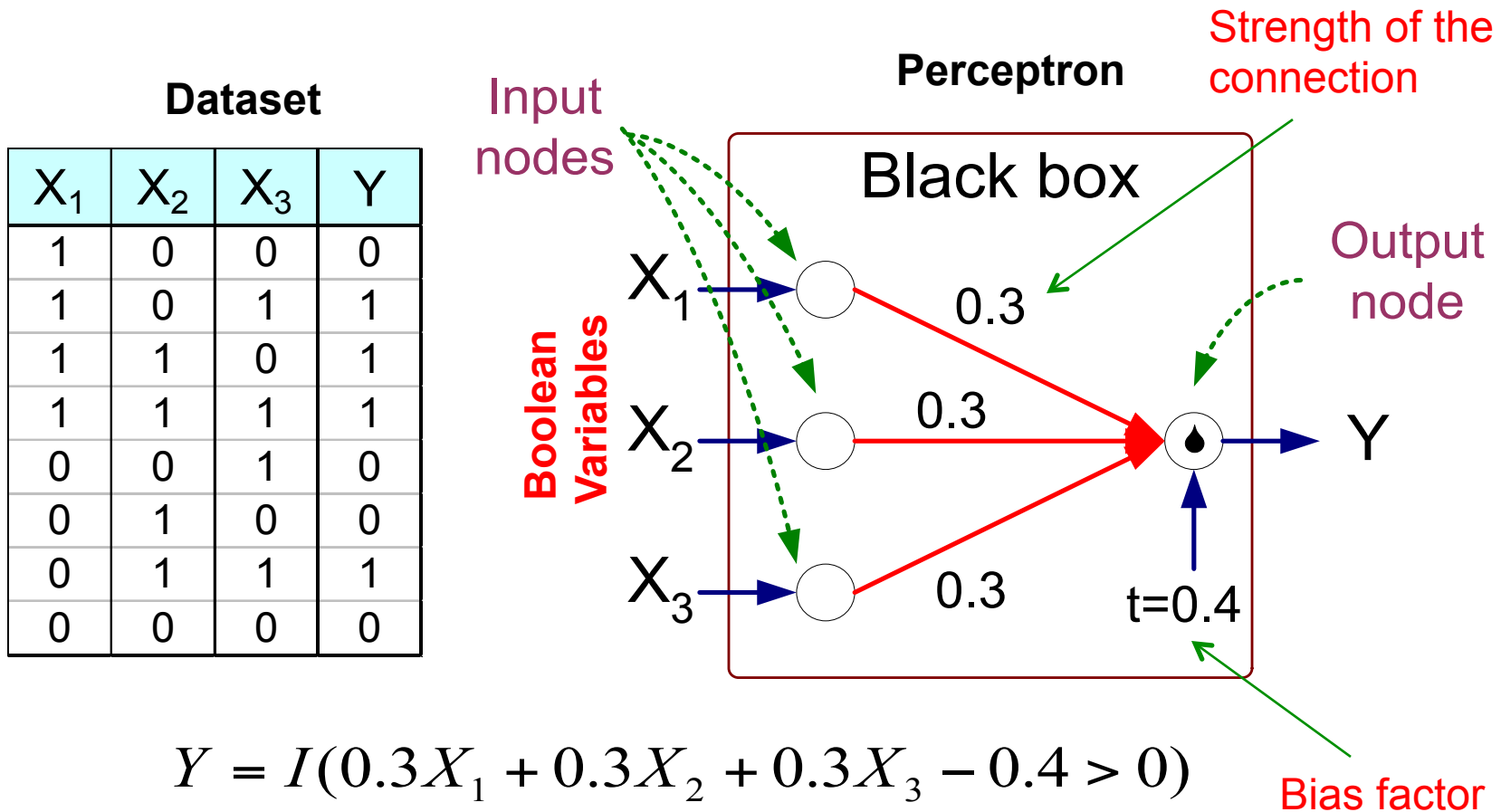

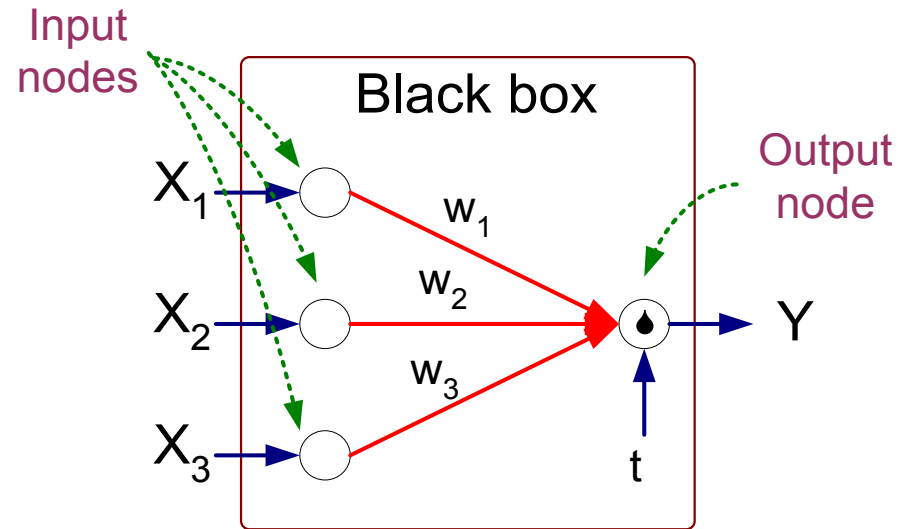
Artificial Neural Networks (ANN)



where $I(z) = \begin{cases} 1 & \text{if } z \text{ is true} \\ 0 & \text{otherwise} \end{cases}$

Artificial Neural Networks (ANN)

- Model is an assembly of inter-connected nodes and weighted links
- Output node sums up each of its input value according to the weights of its links
- Compare output node against some threshold t

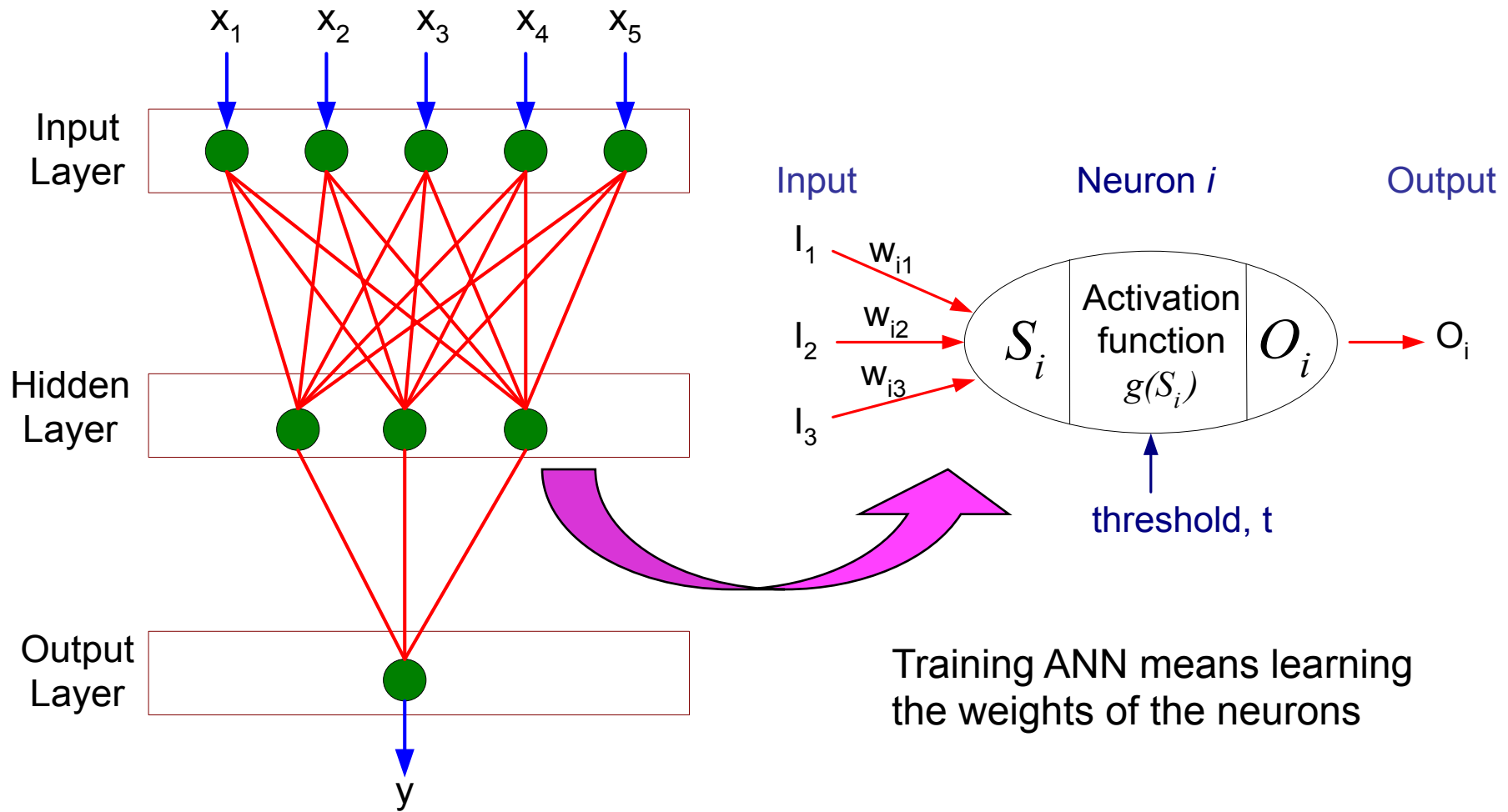


Perceptron Model

$$Y = I\left(\sum_i w_i X_i - t\right) \quad \text{or}$$

$$Y = \text{sign}\left(\sum_i w_i X_i - t\right)$$

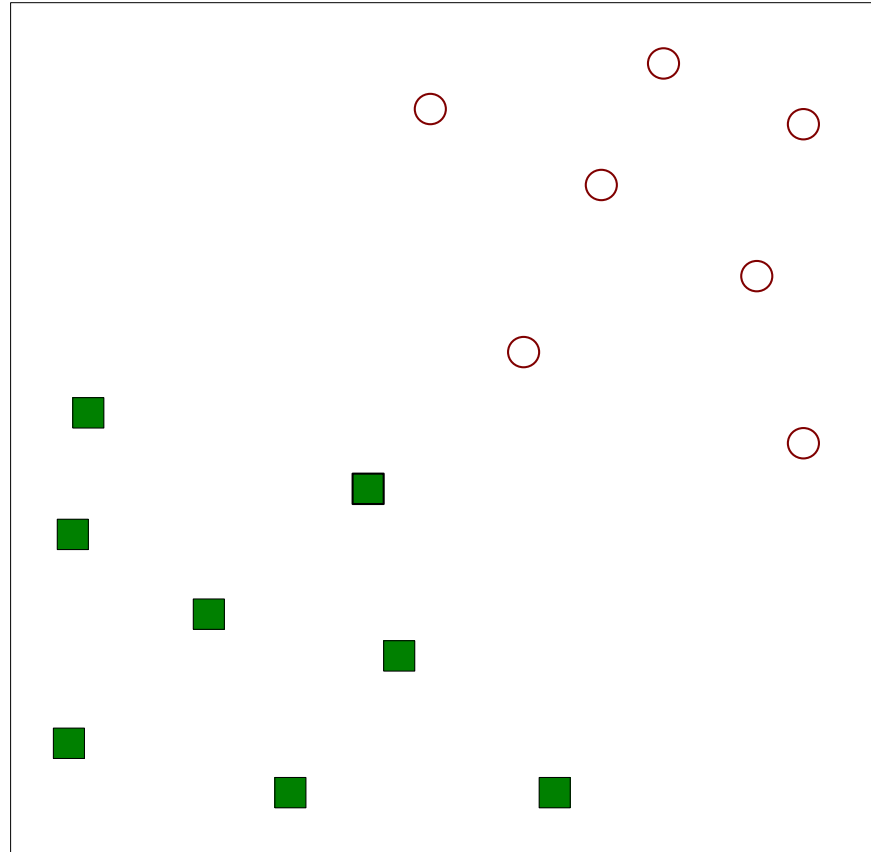
General Structure of ANN



Algorithm for learning ANN

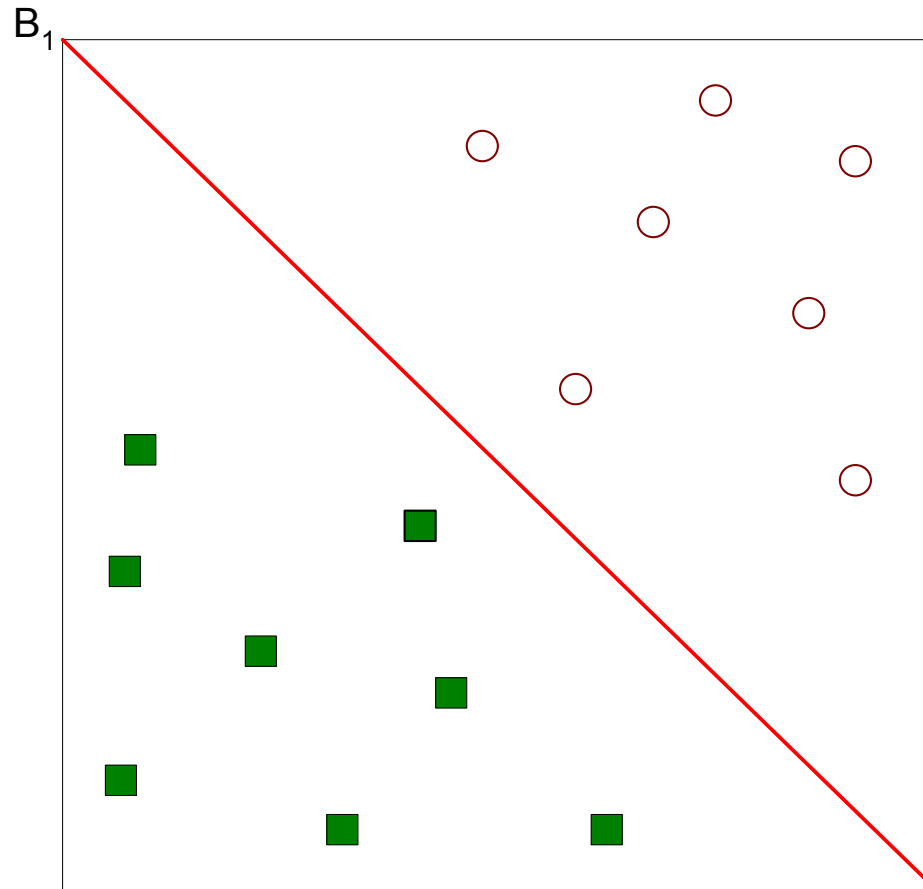
- Initialize the weights (w_0, w_1, \dots, w_k)
- Adjust the weights in such a way that the output of ANN is consistent with class labels of training examples
 - $w_j^{(k+1)} = w_j^{(k)} + a (y_i - \hat{y}_i^{(k)})x_{ij}$
 - Objective function: $E = \sum_i [Y_i - f(w_i, X_i)]^2$
 - Find the weights w_i 's that minimize the above objective function
 - ◆ e.g., backpropagation algorithm (see lecture notes)

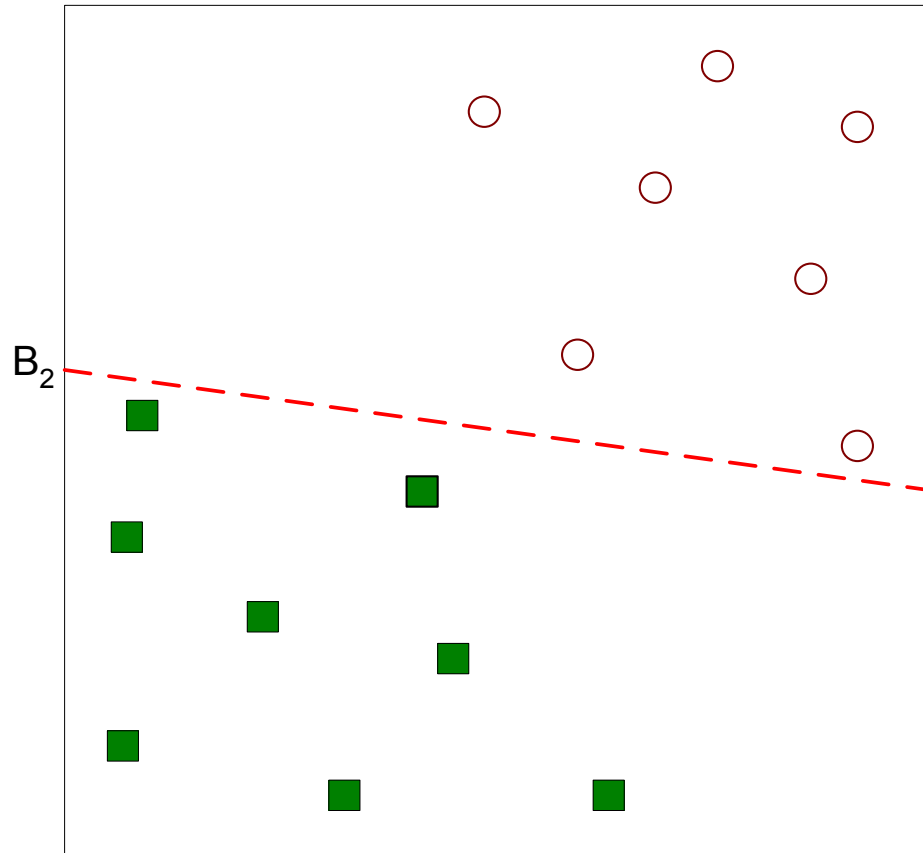

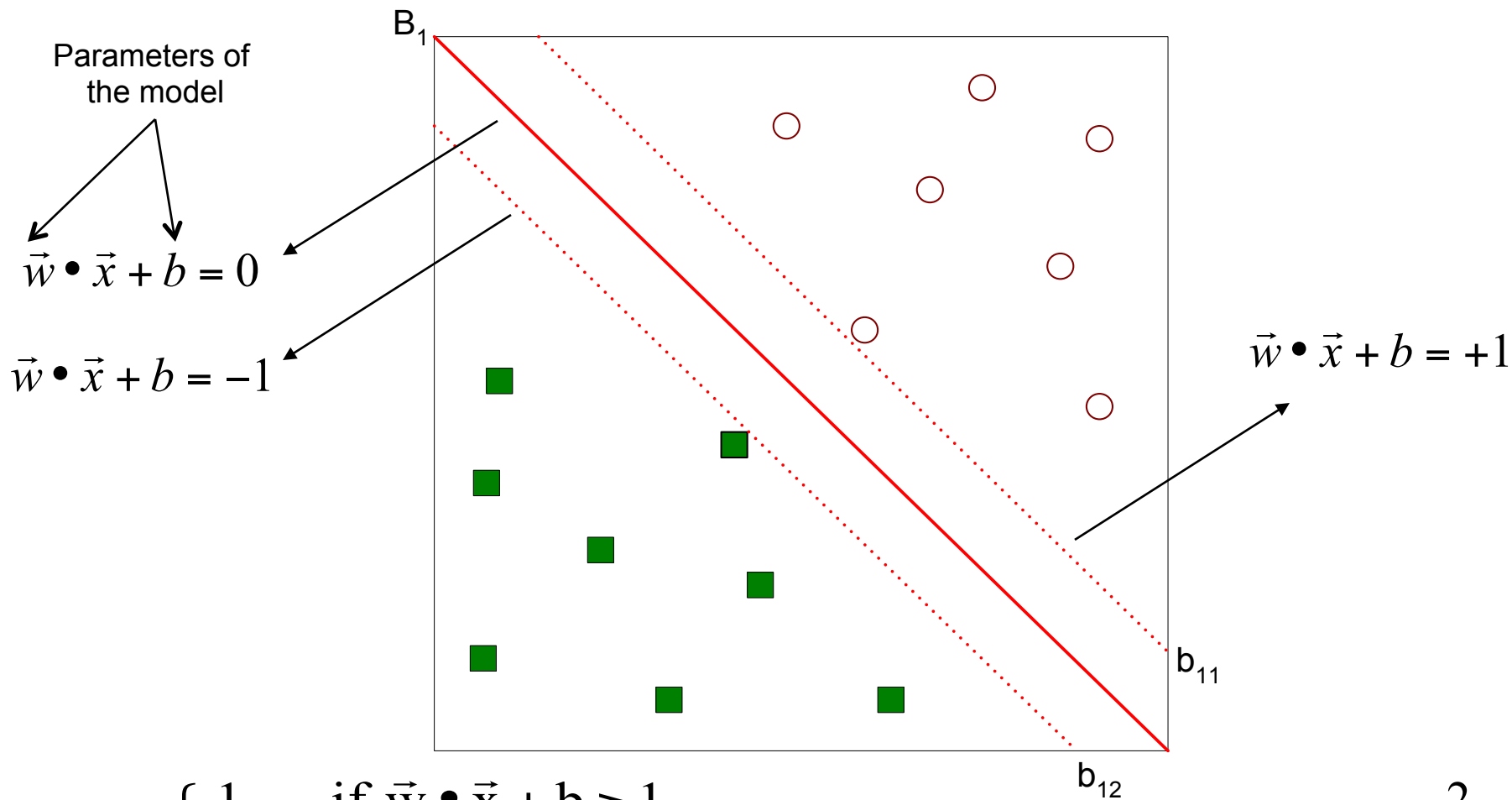

Support Vector Machines



- Find hyperplane **maximizes** the margin => B1 is better than B2

Support Vector Machines



$$f(\vec{x}) = \begin{cases} 1 & \text{if } \vec{w} \cdot \vec{x} + b \geq 1 \\ -1 & \text{if } \vec{w} \cdot \vec{x} + b \leq -1 \end{cases}$$

$$\text{Margin} = \frac{2}{\|\vec{w}\|^2}$$

Support Vector Machines

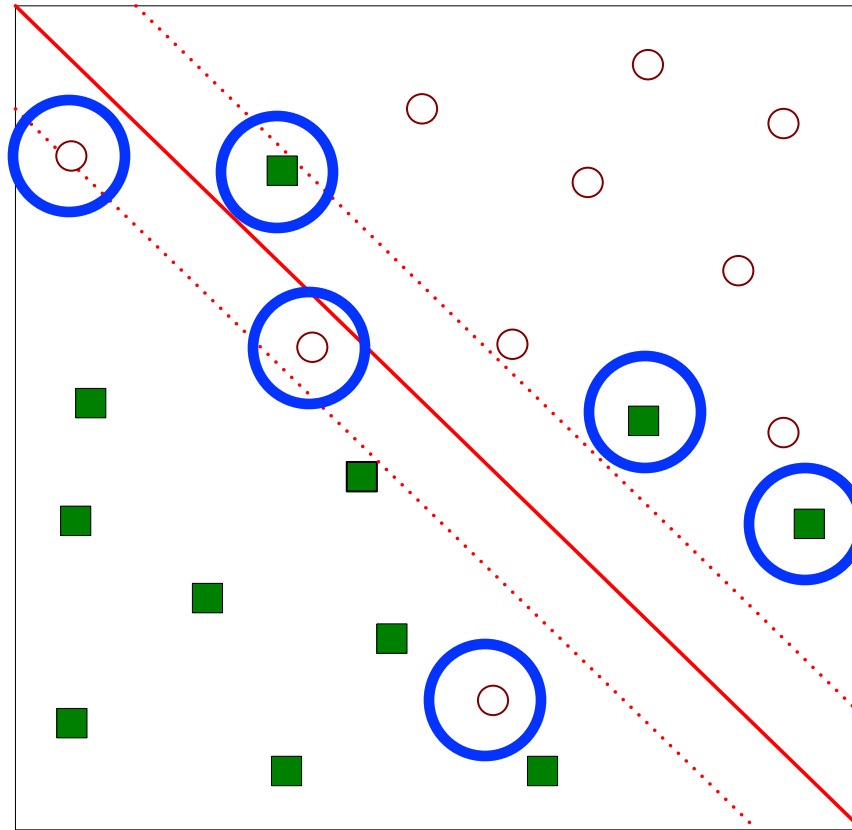
- We want to maximize: $\text{Margin} = \frac{2}{\|\vec{w}\|^2}$
 - Which is equivalent to minimizing: $L(w) = \frac{\|\vec{w}\|^2}{2}$
 - But subjected to the following constraints:

$$f(\vec{x}_i) = \begin{cases} 1 & \text{if } \vec{w} \cdot \vec{x}_i + b \geq 1 \\ -1 & \text{if } \vec{w} \cdot \vec{x}_i + b \leq -1 \end{cases}$$

- ◆ This is a constrained optimization problem
 - Numerical approaches to solve it (e.g., quadratic programming)

- What if the problem is not linearly separable?



Support Vector Machines

- What if the problem is not linearly separable?
 - Introduce slack variables

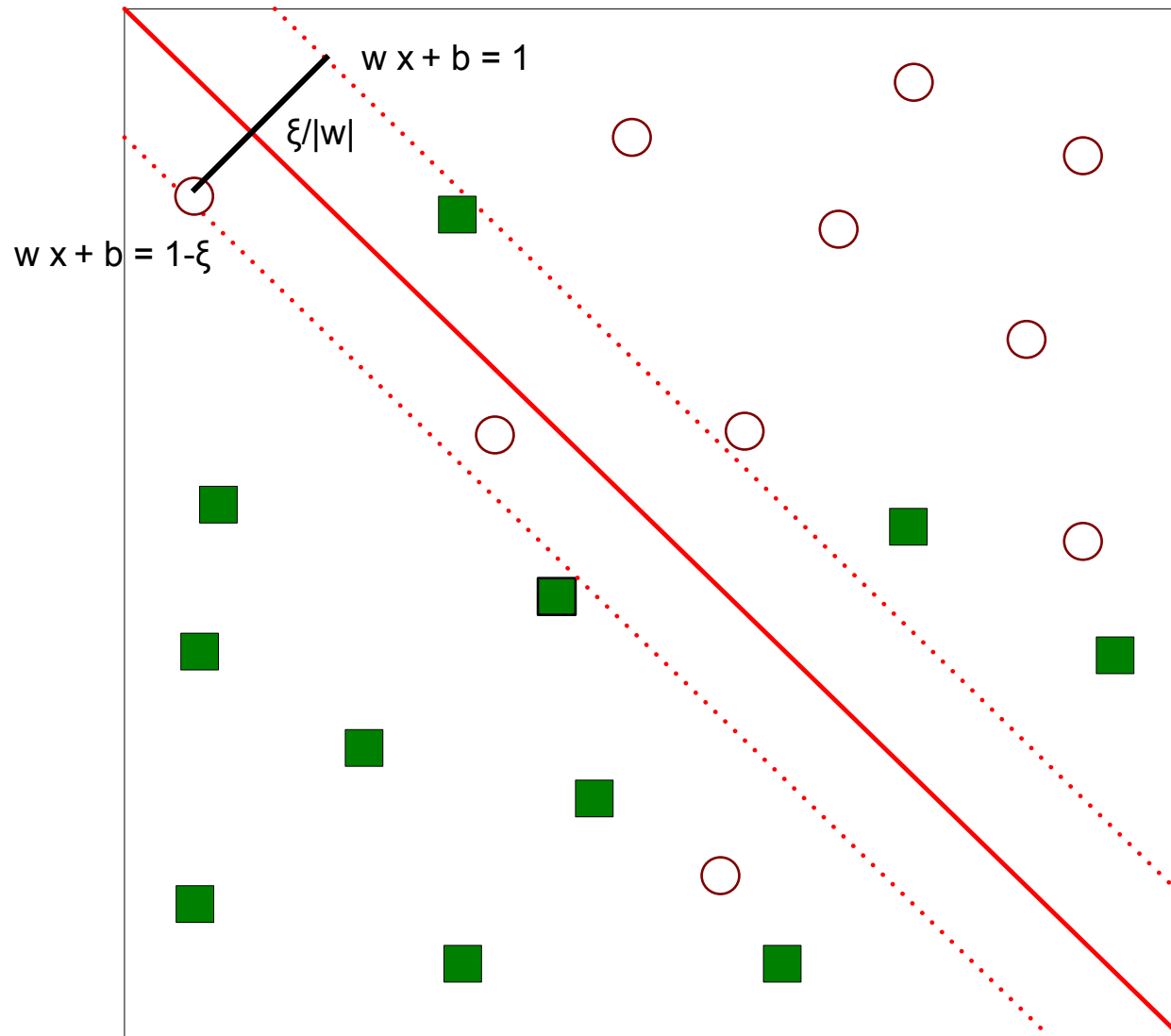
- ◆ Need to minimize:
$$L(w) = \frac{\|\vec{w}\|^2}{2} + C \left(\sum_{i=1}^N \xi_i \right)$$

- ◆ Subject to:

$$f(\vec{x}_i) = \begin{cases} 1 & \text{if } \vec{w} \cdot \vec{x}_i + b \geq 1 - \xi_i \\ -1 & \text{if } \vec{w} \cdot \vec{x}_i + b \leq -1 + \xi_i \end{cases}$$

- ◆ ξ is the trade-off between the width of the margin and the number of the training errors committed by the linear decision boundary

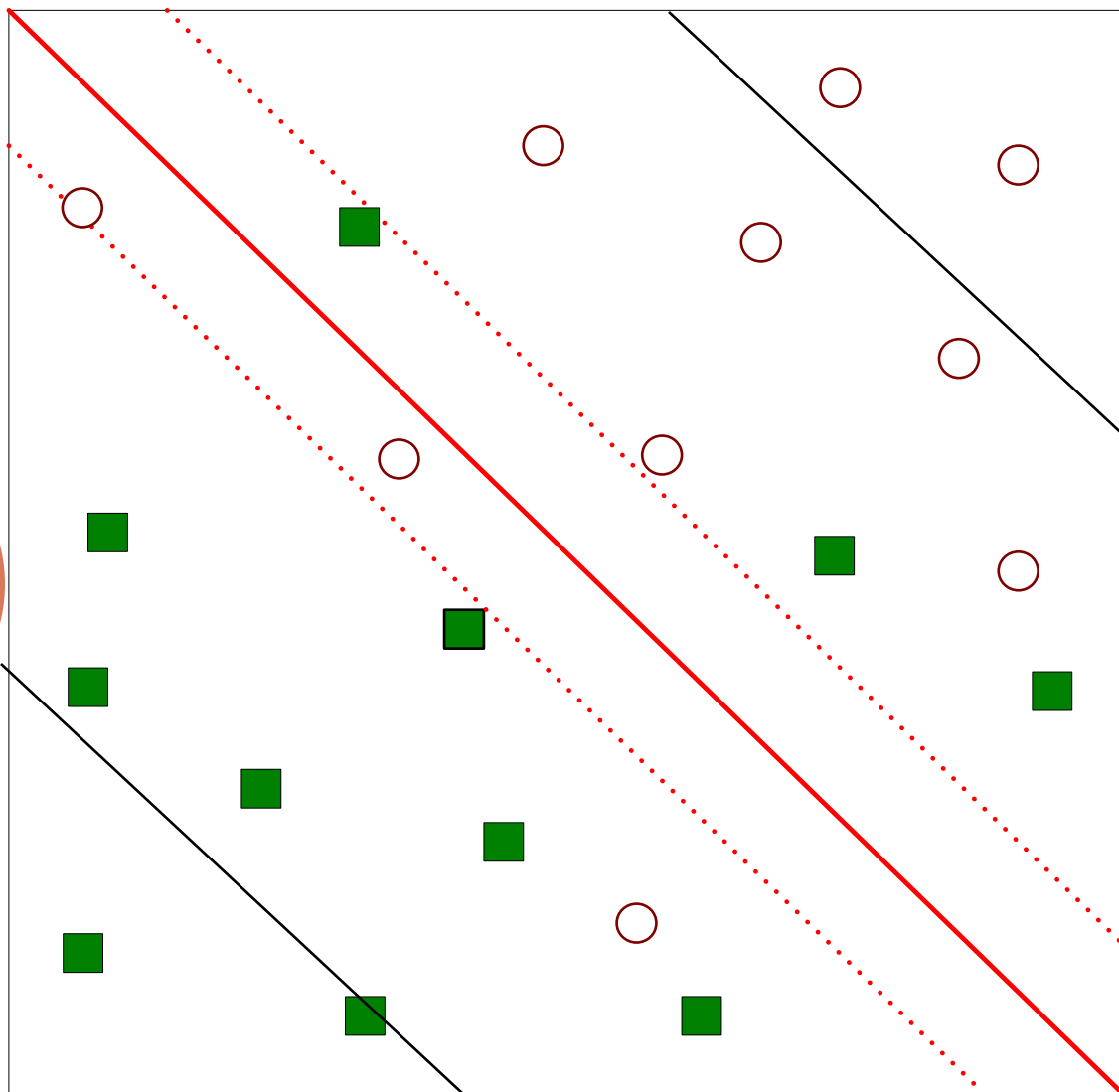
Support Vector Machines

$$L(w) = \frac{\|\vec{w}\|^2}{2}$$

Many training errors committed!!!

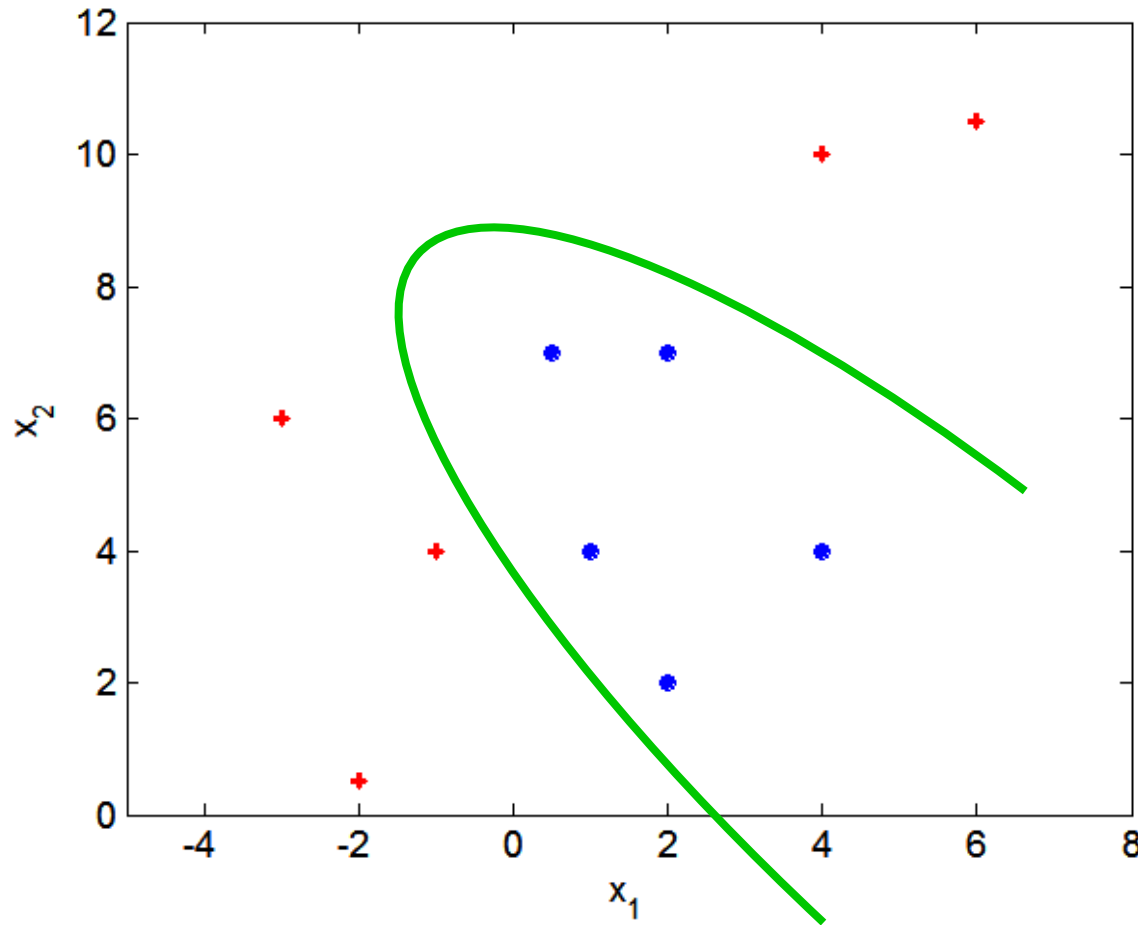
$$L(w) = \frac{\|\vec{w}\|^2}{2} + C \left(\sum_{i=1}^N \xi_i^k \right)$$

Penalizing decision boundary with large values of slack variables



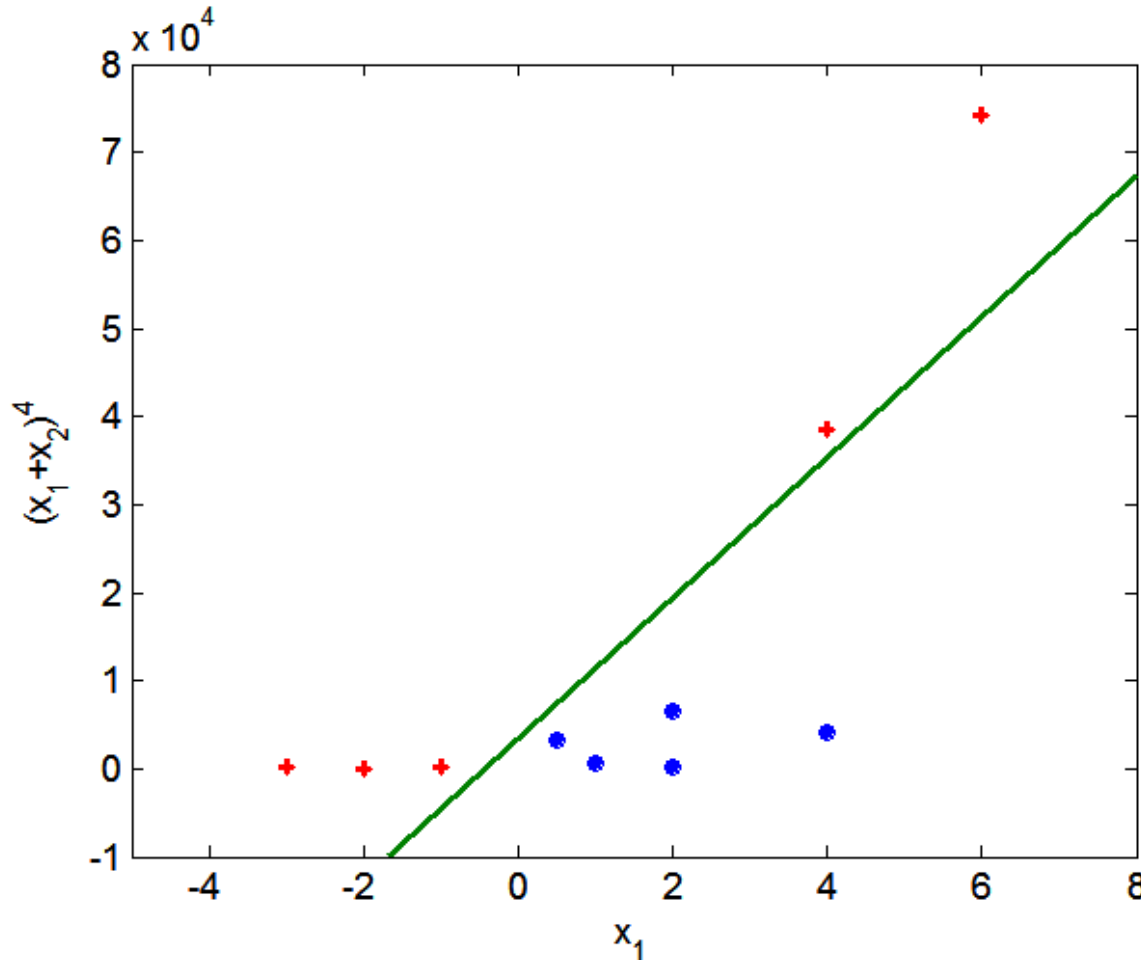
Nonlinear Support Vector Machines

Nonlinear Support Vector Machines

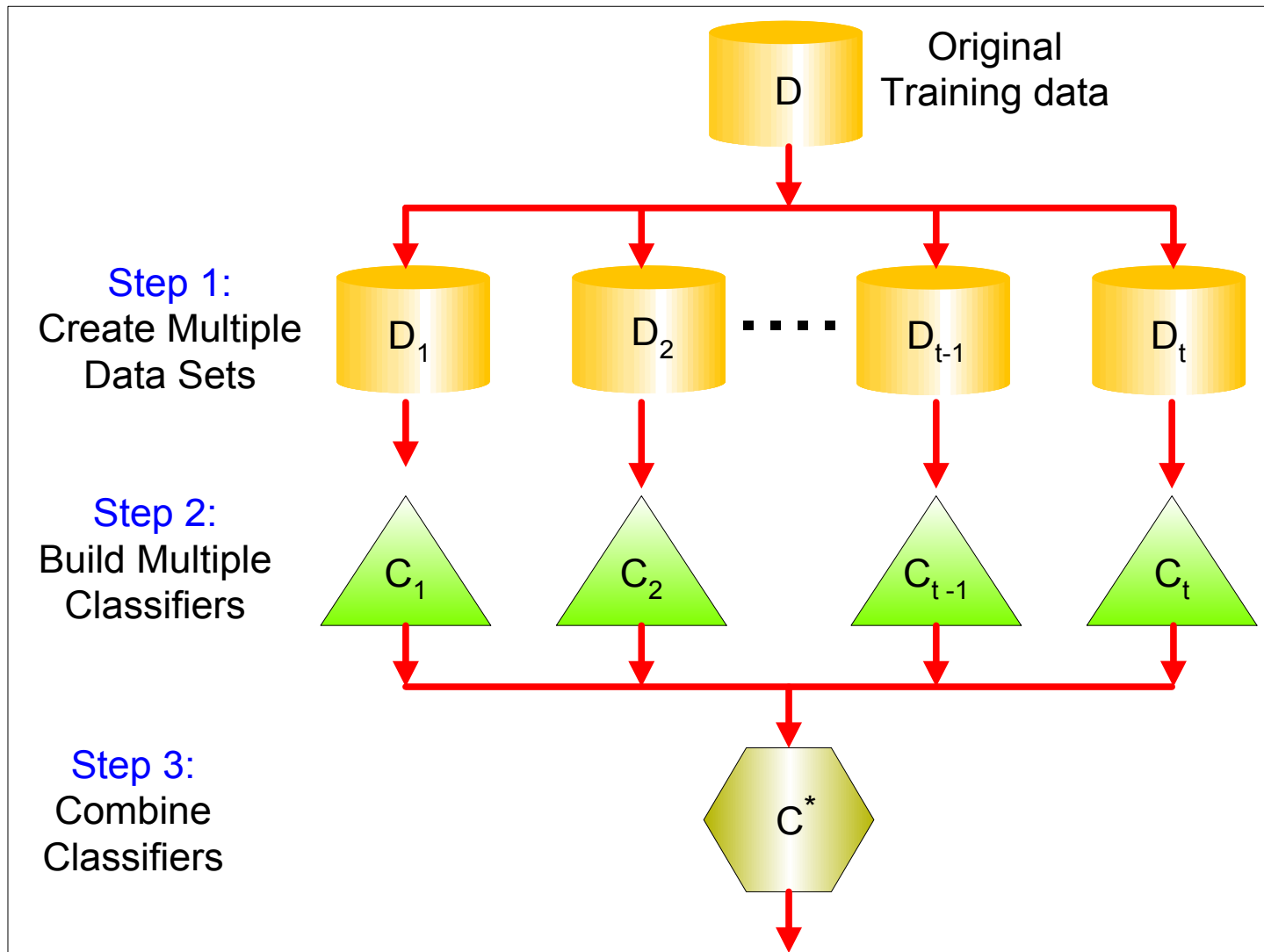
- Transform data into higher dimensional space



Ensemble Methods

- Construct a set of classifiers from the training data
- Predict class label of previously unseen records by aggregating predictions made by multiple classifiers

General Idea



Why does it work?

- Suppose there are 25 base classifiers
 - Each classifier has error rate, $\varepsilon = 0.35$
 - Assume classifiers are independent
 - Probability that the ensemble classifier makes a wrong prediction:

$$\sum_{i=13}^{25} \binom{25}{i} \varepsilon^i (1 - \varepsilon)^{25-i} = 0.06$$

Bagging

- Sampling with replacement according to a uniform probability distribution

Original Data	1	2	3	4	5	6	7	8	9	10
Bagging (Round 1)	7	8	10	8	2	5	10	10	5	9
Bagging (Round 2)	1	4	9	1	2	3	2	7	3	2
Bagging (Round 3)	1	8	5	10	5	5	9	6	3	7

- Build classifier on each bootstrap sample
- Each sample has probability $(1 - 1/n)^n$ of being selected

Bagging algorithm

Training

In each iteration t , $t=1, \dots, T$

- Randomly sample with replacement N samples from the training set
- Train a chosen “base model” (e.g. neural network, decision tree) on the samples

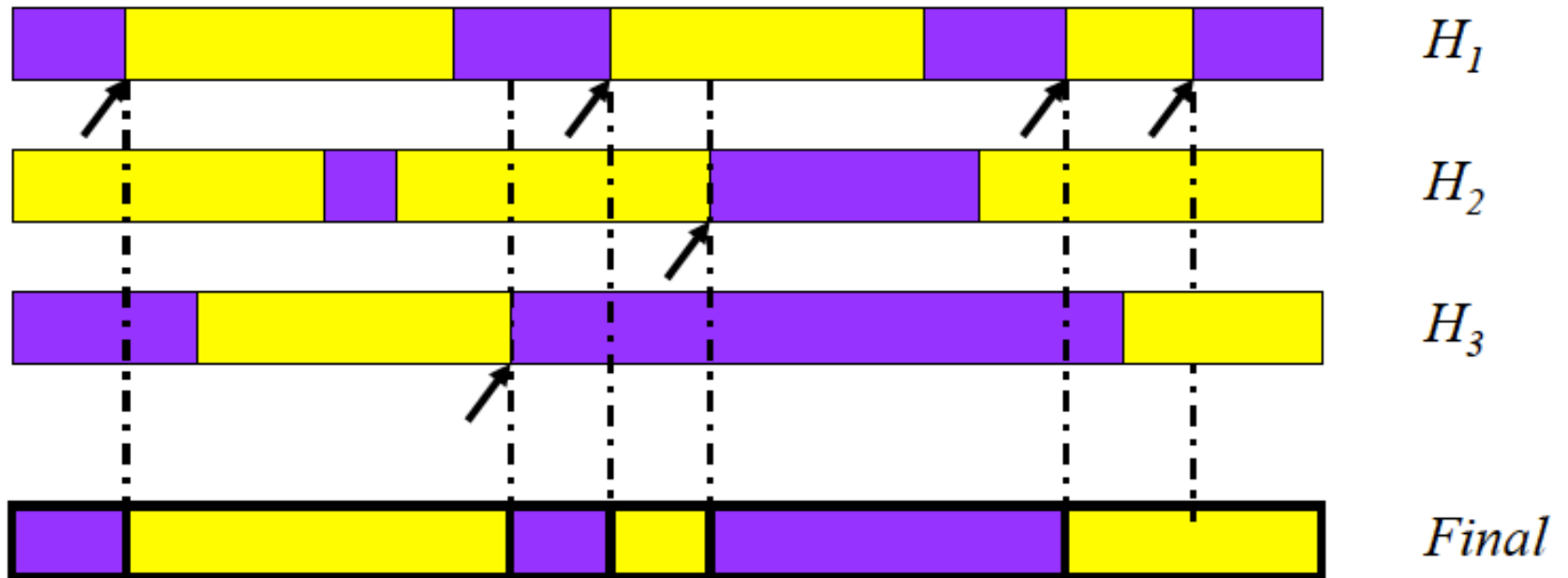
Test

For each test example

- Start all trained base models
- Predict by combining results of all T trained models:
 - ◆ Regression: averaging
 - ◆ Classification: a majority vote

Majority Voting

Test examples

Boosting

- An iterative procedure to adaptively change distribution of training data by focusing more on previously misclassified records (hard to classify)
 - Initially, all N records are assigned equal weights
 - Unlike bagging, weights may change at the end of boosting round

Boosting

- Records that are wrongly classified will have their weights increased
- Records that are classified correctly will have their weights decreased

Original Data	1	2	3	4	5	6	7	8	9	10
Boosting (Round 1)	7	3	2	8	7	9	4	10	6	3
Boosting (Round 2)	5	4	9	4	2	5	1	7	4	2
Boosting (Round 3)	4	4	8	10	4	5	4	6	3	4

- Suppose for example 4 is hard to classify
- Its weight is increased, therefore it is more likely to be chosen again in subsequent rounds

Example: AdaBoost

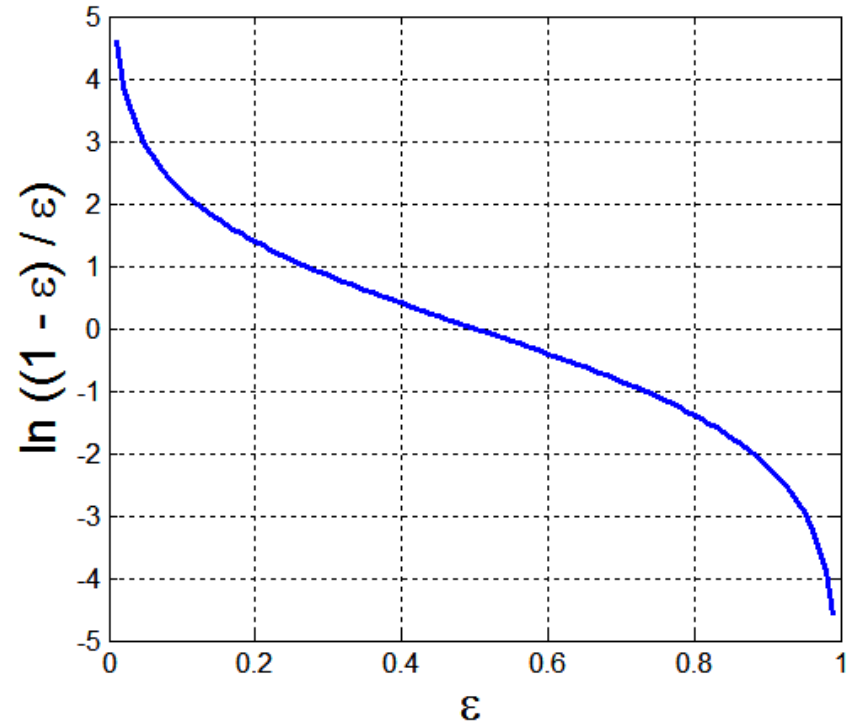
- Base classifiers: C_1, C_2, \dots, C_T
- Error rate:

$$\varepsilon_i = \frac{1}{N} \sum_{j=1}^N w_j I(C_i(x_j) \neq y_j)$$

$I(p)=1$ if p is true 0 otherwise

- Importance of a classifier depends on the error rate:

$$\alpha_i = \frac{1}{2} \ln \left(\frac{1 - \varepsilon_i}{\varepsilon_i} \right)$$



Example: AdaBoost

- Weight update:

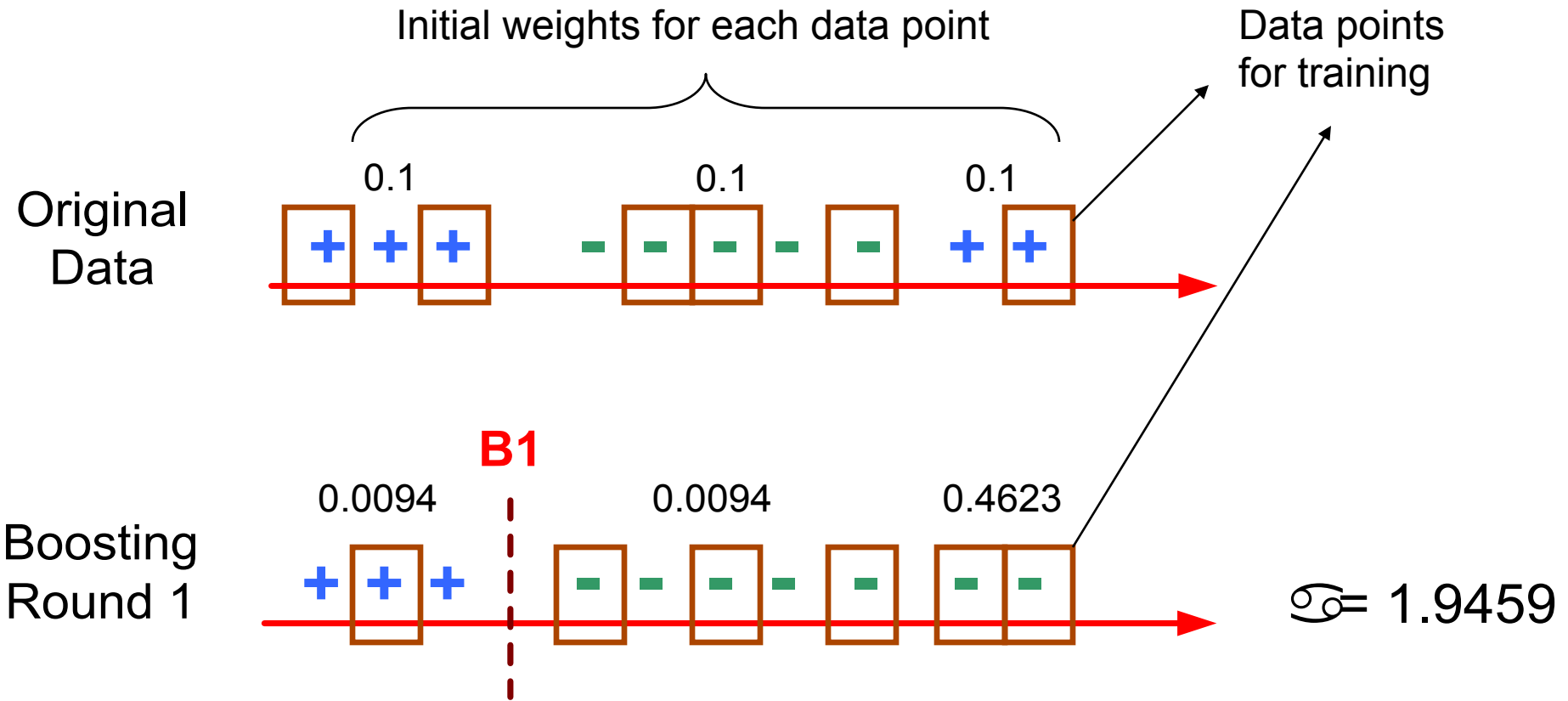
$$w_i^{(j+1)} = \frac{w_i^{(j)}}{Z_j} \begin{cases} \exp^{-\alpha_j} & \text{if } C_j(x_i) = y_i \\ \exp^{\alpha_j} & \text{if } C_j(x_i) \neq y_i \end{cases}$$

where Z_j is the normalization factor

- If any intermediate rounds produce error rate higher than 50%, the weights are reverted back to $1/n$ and the resampling procedure is repeated
- Classification:

$$C^*(x) = \arg \max_y \sum_{j=1}^T \alpha_j I(C_j(x) = y)$$
